The public hearing will be held to gather public input on the amendment to the Waupaca County Comprehensive Plan. The Waupaca County Comprehensive Plan was adopted by the Waupaca County Board of Supervisors on September 18, 2007. The proposed amendment to the Comprehensive Plan Preferred Land Use Map is within the Town of Dayton. The map amendment is to ensure that the Waupaca County Comprehensive Plan remains consistent with the locally adopted comprehensive plans.

Wachsmuth</u>: Located in Sec. 2, Town of Dayton, lying along Polly Road, Fire Number E2002 & E2016, Waupaca County, Wisconsin; for a Petition for Zoning Map Amendment from an RR (Rural Residential) District to an RC-G (Rural Commercial-General) District for the construction of Mini-Warehouses on two (2) separate parcels being approximately 1.10 & 1.110 acres.
