## COMPREHENSIVE PLAN AMENDMENT:

The proposed amendment to the Comprehensive Plan Preferred Land Use Map is within the Town of Mukwa. The map amendment is to ensure that the Waupaca County Comprehensive Plan remains consistent with the locally adopted comprehensive plans.

Reese</u>: Located in Sec. 31, Town of Wyoming, lying along West Hill Road, Fire Number N9859, Waupaca County, Wisconsin; for a Conditional Use Permit application for the placement of a recreational vehicle intended for temporary living purposes in excess of 30 days in an AR (Agriculture Retention) District on approximately 11.88 acres.
