Judge Jim Morrison speaking on behalf of Marinette County and Drug Court:

- Marinette County has a severe drug issue
- At first drug court was viewed with skepticism is now highly regarded and supported
- There are different models of drug court it is important to tailor to county needs
- At present Marinette County has 21 felons in drug court and they are all sober
- Drug court offers 3-5 years of extensive supervision
- Recidivism w/o drug court is 90%, with drug court 50%
- There are trainings and webinars available
- Marinette County Drug Court values
 - Do what works
 - Treat the addiction, not the use
 - Don't punish people for addict behavior
 - Discipline for non-compliance
- Marinette County Drug Court treats high risk-high need
- Most offenders would normally spend 120-150 days in jail before prison
- Anthony House stabilizes clients for 7-10 days
- Clients are required to put in 40 hours per week in a combination of treatment, work and volunteering
- Drug tests are done on a 24 hour, seven day random schedule
- Local hospital does the urinalysis. The client pays if it is positive, drug court pays if it is positive
- Most clients can get treatment through third party insurance
