- 1. Meeting was called to order and open meeting statement was read by Supervisor Kietzmann at 8:33 a.m.

3. Review and accept Agenda

Motion was made by Supervisor Neumann to accept the January 29, 2018 agenda; second was made by Supervisor Nygaard. The agenda was approved unanimously by committee members.

 - Current programs and outcomes

Written reports from Kelly Hammond, Greg Blonde and Penny Tank were emailed to those supervisors requesting them as well as distributed to those preferring to receive them at the meeting. Jessica Beckendorf will submit her report to the committee. Hammond and Tank highlighted the following from the provided reports:

- Kelly is staying busy with FMLAs coming and going! They will only miss 12 out of hundreds of teaching lessons.
- Penny mentioned Super Saturday and invited committee to participate and visit. Penny also mentioned youth Colors training partnership with Jessica for "SPARKS" with DHHS.

- Educator Presentation Greg Blonde highlighted:
 - > Greg reviewed his monthly report and post-tenure review document.
 - Greg just finished Cow College. Greg had 5 UW-Specialists attend to teach on a variety of relevant topics.
 - Greg has been doing some farm calls. Most calls are about financial challenges. Greg showed a slide of a graph of net farm income and changes over time. He showed the cycle, but also the significant lows we are currently in now, that are likely to be prolonged more than normal. 2018 outlook is also not promising. Greg then shared "survival strategies" that he teaches when he works with producers on financial issues.
 - Greg mentioned the AEA (Ag Enterprises Area) in Waupaca-Outagamie counties. His role is to assist planning department with outreach.
 - Greg encouraged committee to read his Faculty review documents. He thanked the committee for their support of his work.
- Administrative and Department Report update on work of the Area Extension Director, and Department, Area and State updates for previous month Catherine Neiswender provided a report of her monthly work ad Department Lead and AED. Catherine sought committee feedback on the annual performance review process with the staff and committee. This will occur during the February meeting. Reports will be short, with an opportunity for the committee to confidentially provide feedback to Catherine during a closed session at the end of the meeting. Catherine also mentioned PILD application process opportunity.
