Judge Elect Huber pledged to work with and support the County Board, he asked that they please come and talk to him if you have questions or problems, his door is open and he looks forward to working with them in the future.

Our Young People – What's Wrong? What's Right? What's Next?

Dr. James Fico, Coordinator of Health & Family Services, Jonathon Cloud, Development Associates of Miami, Florida

Dr. Fico introduced Jonathon Cloud, a technical advisor here to help us prevent problems in the future with children and families at risk. The process is underway here in Waupaca County, people want to and need to know the what's wrong, what's right and what's next. The strategy consists of 3 types of children: 1. The healthy doing well, keep them that way-prevention; 2. The begin to get into trouble-early on need to identify them to help intervene – early intervention; and 3. Bad from the start and serious offenders-corrections, trying to rehabilitate. Gather information in those three areas to identify what's going right, need to have factors in place or increase these factors in these children's life. Cloud is helping us gather the information for these most prevalent risk factors, to be able to choose the right types of programs. Analysis will be done by September and will bring back a profile to the County to answer these three things.

Report No. 2 (2000-2001) Waupaca County Library Service Plan – 2000-2004

The Plan was distributed last month to the supervisors. Supr. Rasmussen moved and Supr. Bonikowske seconded the motion to approve the Waupaca County Library Service Plan 2000-2001. Motion carried 26-0. Supr. Hillskotter thanked the committee for their input and reported that the process went very well. Report will be placed on file in the Clerk's office.

Report No. 3 (2000-2001) 1999 Sheriff's Dept. Annual Report — Sheriff Liebe

Sheriff Steve Liebe distributed his report to the Supervisors. Sheriff Liebe thanked his staff, they're the ones that make the department run. Supr. Flink moved and Supr. Jonely seconded the motion to place the report on file. Motion carried 26-0 Report will be placed on file in the Clerk' Office.

Report No. 4 (2000-2001) Public Trust & Confidence Conference, Clerk of Courts Terrie Tews

Clerk of Courts Terrie Tews reported that she attended the National Association for Court Management Midyear Conference in Kansas City, Missouri. She plans on rebuilding communication with the public. She thanked the Board for allowing her to attend the conference, it was a worthwhile experience.

Supr. Rasmussen moved and Supr. Koeppen seconded the motion to approve Clerk of Courts report. Motion carried 26-0.

Report No. 5 (2000-2001) 1999 Solid Waste/Recycling Annual Report – SW/Parks Director Roger Holman

Roger Holman reported that 1999 was the fifth year of operation of the Processing and Transfer Facility. Over the past decade they have been impressed with the dedication of town, village and city officials who are working in cooperation with the County to protect their community's environment and the health of their citizens in the face of ever increasing demands on local tax dollars and resources. In 2000, the Solid Waste Management Board will continue to address the issues of funding, enforcement, program growth, hazardous waste collection, education and the orderly development of a comprehensive county-wide integrated solid waste management system. The Board and Staff would like to thank the County Board, municipalities, businesses and people of Waupaca County for their positive support of the programs and look forward to working together in addressing any and all future solid waste needs as we enter the new millennium. Supr. Bonikowske would hope we could finance this with user fees. Asked about costs, complimented them of their services that they provide.

Supr. Kietzmann moved and Supr. Sorensen seconded the motion to approve Report No. 5 and place the report in its entirety on file in the Clerk's office. Motion carried 26-0.

Any other Committee Reports. Special Building Projects Chair Hurlbut reported that the bids have been accepted, groundbreaking will take place in about a week.

Public Property Committee Chair Rasmussen commented that parking space is a very sensitive issue, we're hurting for space but they are working on it. Commended the Highway Committee and Department for the work they have done and how they have

responded to their requests. Supr. Bonikowske complimented Highway Department for their work at Lakeview Manor.

- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.
