### **2001 PROPOSED BUDGET Jim Bernhagen, Finance Manager**

Jim Bernhagen presented the 2001 budget, gave a brief overview and reviewed the Budget Summary. The combined mill rate is \$5.73 per thousand for the year 2001 which would be a 21 cent increase. New personnel positions were reviewed. The Summary of Waupaca County's 2001 Proposed Operating, Special Purpose and Debt Service Budget sheet is on the following page. #### REPORTS FROM OTHER COMMITTEES

Supr. Rasmussen of the Public Property Committee would like to lay over the selling of the county-owned property in the Town of Royalton for 90 days.

Supr. Hurlbut informed the Board on the construction of the Law Enforcement Center. Construction is about 3 weeks ahead of schedule and the change orders are being kept to a minimum and on budget.

Supr. Rasmussen reported on the new parking lot and it is in good shape but is being used for construction supply storage. Supr. Hurlbut informed the board that there is a cost savings in accepting all the construction materials as soon as the contractors can get them.

### Amend Chapter 3 of the Waupaca County Code of Ordinances Personnel Policies & Procedures

### Policy Regarding Personal Property:

Waupaca County is not responsible for personal property stored or used by employees of the County while performing their assigned work duties or left on County property during or after working hours. Employees are solely responsible for their own personal property they choose to have with them during working hours. Waupaca County will not indemnify or otherwise compensate employees for lost, damaged, or stolen personal property left on County property or at any County work-site during or after working hours. Employee is defined as any individual who is employed by the County and is paid in part or whole through the County payroll.

This policy will be effective immediately upon passage by the Waupaca County Board of Supervisors.

Universities & Colleges have written papers on the subject but no one is addressing the problems created by the introduction of these beetles into the United States by the Department of Agriculture in 1977. Originally beneficial for farming & gardening operations & new sources were identified which also are thriving and multiplying, migrating to new areas throughout the US.

PROBLEM: The Beetles have become a serious problem, will continue to worsen for rural & city residents in Wisconsin & Waupaca County. No real method of control is available to households, and it should not be the responsibility of non farming citizens to provide over winter housing and shelter to these so called Lady Bugs. We should not have to spend hours and days vacuuming the outside of our houses trying to prevent the intrusion of these pests. Suggested prevention methods are noneffective as they can gain access through paper thin openings. REQUEST: A possibility that would help control these beetles would be to make it illegal for Farm & Gardening supply catalogue companys to sell these beetles by the quart which they CURRENTLY DO.

I believe a proclamation by the Waupaca County Board of Supervisors is in order and request of intervention to the State & Federal Government be sent to remedy this public nuisance originally created by the USDA. Waupaca County should be the first to request such action of & by our Government.
