REPRESENTATIVE TO THE ASSEMBLY JEAN L. HUNDERTMARK

Representative Hundertmark presented Chairman Brown with a framed copy of the original Articles of Incorporation, incorporating Waupaca County as a county on February 17, 1851.

INTRODUCTION OF DNR CONSERVATION WARDEN KENNETH THOMSON

James Rice thanked the Board for their cooperation and support over the years and thanked them for the resolution the Board presented him. Jim Rice introduced DNR Conservation Warden Kenneth Thomson, who is assigned to Waupaca County. Warden Thomson will have an office at Hartman Creek State Park. Warden Thomson has been a warden for 3 years and is originally from Superior.

WAUPACA COUNTY HIGHWAY DEPARTMENT CAPITAL IMPROVEMENT PROGRAM 2001-2005 HIGHWAY COMMISSIONER DEAN STEINGRABER

Highway Commissioner Dean Steingraber presented the Highway Department's Capital Improvement Program. Dean Steingraber reported that 6 townships have formally adopted the capital improvement plan and there are more townships that are taking it to their town boards for review.

Supr. Flink moved and Supr. Whitman seconded the motion to accept the Waupaca County Highway Department Capital Improvement Program 2001-2005. Motion carried 22-0.

OTHER COMMITTEE REPORTS

Supr. Hurlbut reported that the new jail project is going well and that the transfer of prisoners to the new facility is scheduled for August 28. Administrative Captain Kneisler reported that hiring of new officer is going well.

ORDINANCE 6.0 AMENDMENT

WHEREAS, Waupaca County Board of Supervisors has previously passed an ordinance allowing for the Sheriff to be reimbursed for the cost of boarding prisoners, and

WHEREAS, Wisconsin Act 281 amended Section 302.38(4) Wisconsin Statutes to the governmental unit paying for the cost of medical or hospital care to collect the cost of the care from the prisoner or the prisoner's estate,

NOW THEREFORE BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain and amend Waupaca County Ordinance 6.0 as follows:

6.06A Reimbursement per day costs and medical care of prisoners:

The Sheriff in accordance with Sections 302.38(4) and 302.372(2) Wis. Stats., shall collect fees and medical/health care costs of prisoners under the following procedures:

- Inmates and prisoners sentenced to the Jail shall be assessed an initial twenty-five (\$25.00) dollar booking fee and a daily fee of ten (\$10.00) dollars per day for each day of incarceration in the Waupaca County Jail.
- Huber Law inmates shall be charged a rate of fifteen (\$15.00) dollars per day while exercising Huber Law privileges.
- Inmates and prisoners will be responsible for the costs of their medical and dental care, prescriptions and other personal needs (such as eyeglasses) during incarceration.
- The Sheriff or his designee shall require that all prisoners complete a financial disclosure form to be used to determine viability of pursuing reimbursement of costs.
- The Sheriff or his designee shall deduct the costs incurred by the County from the prisoner's canteen account.
- Within 12 months of release, the Sheriff and/or the Sheriff's designee shall assess the costs incurred by the prisoner and commence a civil action pursuant to Section 302.372(6) Wis. Stats.

6.06B Approved by Law Enforcement Committee on February 13, 2001. This Amendment will become effective and enforceable immediately upon adoption by the Waupaca County Board.

Supr. Jonely moved and Supr. Bonikowske seconded the motion to amend Ordinance 6.0. Motion carried 22-0. Passed this 20th day of February, 2001.

AMENDMENT TO CHAPTER 34 Town of Lind A-G to O-N 2001-01-446 Z-1-01

Parcels #12-03-12-4, 12-03-13, 12-03-21-1 and 12-03-24, Z-1-01, Vincent L. & Kathleen M. Nickel in Sec. 3, Town of Lind for a Zoning Map Amendment from A-G (General Agriculture) zone and O-N (Natural Resource Preservation) zone to M-G (General Manufacturing) zone for sales, parts and service of agricultural and consumer equipment.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ and the E $\frac{1}{2}$ of the

NW ¹/₄ of Sec. 3, Town of Lind, lying south off of U. S. Highway "10", Waupaca County, Wisconsin, on approximately 126 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Lind Township, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from A-G (General Agriculture) zone and O-N (Natural Resource Preservation) zone to M-G (General Manufacturing) zone.
- Section 2. This ordinance shall be in full force and effect in the Town of Lind upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors does hereby approve changing two limited part-time position to one regular parttime activity position at Lakeview Manor.

RESOLUTION NO. 38 (2000-2001) State of Wisconsin Financial Support for Infrastructure Development for Local Public Health Departments

SUBJECT: State of Wisconsin Financial Support for Infrastructure Development for Local Public Health Departments.

WHEREAS, preparation of the 2001-2002 biennial budget is now in progress; and

WHEREAS, The Department of Health and Family Services mission is "to lead the Nation in fostering healthy, self-reliant individuals and families"; and

WHEREAS, Local Public Health Departments in 1998 spent an average of \$11.28 per capita of local tax dollars to provide Core Public Health functions mandated by Ch. 251, Wis. Statutes, and not funded by the State; and

WHEREAS, The Wisconsin Association of Local Health Departments and Boards (WALHDAB), and the Wisconsin Environmental Health Association (WEHA), and the Wisconsin Public Health Association (WPHA) have developed a special study committee (WWW) to look at this same issue; and

WHEREAS, The State of Minnesota 1998 legislation appropriated Nineteen Million, One Hundred-Twenty-Two Thousand Dollars (\$19,122,000.00), of which Five Million Dollars of this Community Health Service appropriation went for core functions support for Local Public Health Departments in that state; and

WHEREAS, the State of Illinois in their 2000 fiscal year via a Local Health Protection Grant allocated Thirteen Million, Sixty-Four Thousand, Four Hundred Dollars (\$13,064,400.00), targeted to go to Local Public Health Departments that are certified for services or infrastructure purposes.

NOW, THEREFORE, LET IT BE RESOLVED that the Governor's budget message to the Wisconsin State Legislature include provisions for full funding of core Public Health functions mandated by the State but delegated to the Local Health Departments.

WHEREAS, the Waupaca County Board of Supervisors has previously approved the incremental hiring of fourteen (14) additional corrections officers to staff the new Waupaca County Jail, with a group of four officers added on January 1, and two groups of five officers to be added on April 1 and July 1, 2001; and

WHEREAS, jail operations must transfer to the new facility by August 28th rather than December 1, 2001 as originally planned; and

WHEREAS, additional time is necessary to permit training and evaluation of new officers; and

WHEREAS, inmates housed in other jails will be returned to Waupaca County three months earlier than expected, resulting in savings of approximately \$215,000.

NOW, THEREFORE LET IT BE RESOLVED that the April 1 and July 1, 2001 hirings be accelerated to March 1 and April 15, 2001, respectively at an additional projected cost of \$62,373.50.
