Pledge of Allegiance was said by all followed by a moment of silence.

REPORT NO. 1 (2001-2002) W-2 Report - Chris Machamer, DHHS

Chris Machamer requested approval to continue the W-2 program in Waupaca County in 2002-2003. The State will be accepting proposals from agencies that intend to operate the program for a 2 year contract period. Waupaca County has earned what is known as the right of first election for this process. If Waupaca County wishes to continue operating the program, Waupaca County will not receive any competition for it. Waupaca County earned the right of first election by meeting six performance standards in 2000. Waupaca County Department of Health & Human Services continues to be the best choice for operating the W-2 program in Waupaca County.

RESOLUTION NO. 1 (2001-2002)

SUBJECT: The Health and Human Services Board recommends the Department to continue to administer the Wisconsin Works (W-2) program for Waupaca County residents in the years 2002 and 2003.

WHEREAS, on July 16, 1996, the Waupaca County Board of Supervisors authorized, by Resolution #2 (1996-1997), the Health and Human Services Department to submit a notice of intent to administer the new W-2 program in Waupaca County; and

WHEREAS, on May 18, 1999, the Waupaca County Board of Supervisors authorized by Resolution #4 (1999-2000), the Health and Human Services Department to submit a proposal to enter a two year contract (2000-2001) with the State to again administer the W-2 program; and

WHEREAS, the Department received from the State of Wisconsin a letter dated February 16, 2001 congratulating our W-2 Agency of earning the "Right of First Selection" by meeting both the program and financial criteria required in the current contract; and

WHEREAS, program expenses associated with the W-2 Agency have been fully funded by the State of Wisconsin, in addition to Waupaca County gaining some financial incentives under our current contract agreement to benefit local children and family services and the county; and

WHEREAS, the projected budget figures received from the State for the next two contract years (2002 & 2003) appear challenging and yet reasonable with a local stable economy.

NOW, THEREFORE, LET IT BE RESOLVED, that the Waupaca County Board of Supervisors authorizes the Department of Health and Human Services to submit a proposal to enter a two year contract (2002 & 2003) with the State of Wisconsin to continue to administer the W-2 Agency.

BE IT FURTHER RESOLVED, that the administration of W-2 Agency past December 31, 2003 will require Health and Human Services Board and the full County Board Approval.

OTHER COMMITTEE REPORTS

Supr. Hurlbut reported that things are going smoothly at the new jail. Food service bids have just been accepted and they are significantly below what is being paid now. The project is \$600,000 or more below budget. Tentative occupancy date is August 16. A tour of the new facility will be part of the annual County Board tour.

RESOLUTION NO. 2 (2001-2002)

SUBJECT: The Health and Human Services Board recommends the Department contract for a part-time bilingual (preferred) worker to assist at WIC Clinics.

WHEREAS, the Women, Infant and Children (WIC) Program has been providing services to children and families in Waupaca County since October 1985; and

WHEREAS, the WIC Program annually serves approximately 1,400 infants, children, and parents living in Waupaca County; and

WHEREAS, the Program has been experiencing increases, specifically in minorities, with Spanish being their primary language; and

WHEREAS, the WIC Program has been determined to be the first point of entry into the human services system for many children and families in need; and

WHEREAS, new additional Federal and State prevention and early intervention services, best provided at the WIC Clinics, has placed greater demands on staff time.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors authorizes the Health and Human Services Department to contract for 7 ½ hours per month of part-time WIC Clinic support worker services.

BE IT FURTHER RESOLVED that the Health and Human Services Department may adjust the part-time hours to effectively control services for the program customers.

AND BE IT FURTHER RESOLVED that no county dollars would be used to fund these and any other WIC program expenses.

WHEREAS, the low compensation rate paid by the State Public Defender to certified private attorneys has resulted in an insufficient number of private attorneys willing and able to accept SPD cases, thereby causing increased county costs associated with court appointments and delayed proceedings;

THEREFORE BE IT RESOLVED that the Waupaca County Board strongly urges the Legislature to amend, and fund, the State Public Defender eligibility guidelines to W2 standards with cost of counsel: and

BE IT FURTHER RESOLVED that the Waupaca County Board strongly urges the Legislature to tie, and fund, the compensation rate paid to certified private attorneys by the State Public Defender to Supreme Court Rules 81.02(1).

RESOLUTION NO. 7 (2001-2002) Support for Supreme Court Initiative to Improve Interpretation in Wisconsin Courts

WHEREAS, Wis. Stats. ss. 885.37 sets the criteria for court appointment of an interpreter at public expenses; and

WHEREAS, such statute specifies that the court must provide an interpreter for indigent parties and witnesses in criminal, juvenile, mental health and child protection cases; and

WHEREAS, the cost of court-ordered interpreter services in Wisconsin circuit courts is paid by the individual counties; and

WHEREAS, the State of Wisconsin reimburses at the rate of \$35 per half day, plus mileage only if the party provided with the interpreter is indigent (counties pay for interpreters appointed by judges for nonindigent parties); and

WHEREAS, the current average cost for interpreter services is \$40 per hour; and

WHEREAS, in 1999, counties reported spending \$565,248 on interpreter services while receiving only \$188,000 in state reimbursement; and

WHEREAS, the use of an unqualified interpreter can delay court proceedings, costing counties valuable court time and resources; as well as result in the need for cases to be retried; and

WHEREAS, Wisconsin's population is becoming more diverse; and

WHEREAS, the diversity of Wisconsin's population is expected to increase for at least the next 25 years; and

WHEREAS, the Director of State Courts appointed a Committee to Improve Interpreting & Translation in the Wisconsin Courts; and

WHEREAS, the Committee issued its report in October of 2000; and

WHEREAS, the Committee recommended a three-pronged approach to improving interpreter services in Wisconsin's courts:

- (1) Expand the court interpreter statutes and provide the funding needed for interpreter appointment; provide that interpreters must be appointed when needed for all types of court proceedings to increase the integrity and effectiveness of the courts; guarantee that interpreters be appointed for all parties without requiring that the participant be indigent, as part of the basic right to court access; and ensure that no services required by the federal ADA and the Wisconsin Victim's Rights Act are denied.
- (2) Increase the state appropriation for interpreter services to meet the rising caseload. Additionally, increase the reimbursement rate paid to counties for interpreter services to cover the costs counties must pay to find well-qualified interpreters.
- (3) Develop court rules, interpreter training and certification standards for court interpreters; and

WHEREAS, the Director of State Courts has requested \$1.8 million to cover these services for the 2001-2003 biennium; and

WHEREAS, the Governor's budget increased funding for interpreter services by only \$50,000.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors supports the initiative of the court to improve interpretation in the state of Wisconsin by (1) supporting increased reimbursement to counties for interpreter services; and (2) supporting the development of interpreter certification standards in the state of Wisconsin; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to all area legislators, Governor Scott McCallum, DOA Secretary George Lightbourn, Director of State Courts J. Denis Moran and the Wisconsin Counties Association.

Resolution Opposing 0.1 Percent Sales Tax Referendum

WHEREAS, on February 6, 2001, the Common Council of the City of Green Bay adopted the reports of its Committee on Stadium Funding Alternatives and approved a resolution by Green Bay Mayor Paul Jadin asking County Boards around the state to hold advisory referendums on the possibility of increasing the sales tax by one-tenth of one percent for one year to offset revenue that the City of Green Bay would obtain from selling the naming rights to Lambeau Field; and

WHEREAS, the Waupaca County Board of Supervisors believes that the Green Bay Packers should exhaust all private sector resources, including but not limited to, personal seat licenses for season ticket holders, naming rights for portions of the stadium, and the sale of additional shares of stock *before* asking for taxpayer funded support of private business activities; and

WHEREAS, the City of Green Bay's resolution acknowledges that other revenue sources besides the sales tax are available, such as voluntary contributions and voluntary contribution checkoffs on state income tax forms;

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors strongly opposes the imposition of a state-wide sales tax to finance a new or renovated stadium for the Green Bay Packers and will not hold such an advisory referendum; and

BE IT FURTHER RESOLVED that the County Clerk is hereby directed to send a copy of this resolution to the Governor of the State of Wisconsin, the President of the Senate, the Speaker of the Assembly, the Mayor of the City of Green Bay, the Chair of each County Board in the State of Wisconsin, and each legislator in the Wisconsin Senate and Assembly who represents constituents from Waupaca County.

RESOLUTION NO. 9 (2001-2002) Resolution Requesting a Special Sales Tax for County Jails

WHEREAS, County jails throughout Wisconsin are housing inmates at an unprecedented rate due to criminal statutes enacted by the state legislature requiring longer periods of incarceration in county jails; and

WHEREAS, with each new criminal statute, the state legislature has failed to provide funding for the increase in housing and operational costs resulting from the longer periods of incarceration; and

WHEREAS, the continual increase in jail populations is forcing counties to build and staff new facilities at great costs to property taxpayers; and

WHEREAS, the State of Wisconsin has allowed special sales taxes for multiple purposes other than public safety purposes including, but not limited to, the Milwaukee County Baseball Stadium, the Milwaukee Convention Center, the Brown County Football Stadium, and Premier Resort Areas.

NOW, THEREFORE, BE IT RESOLVED, that the Waupaca County Board of Supervisors goes on record requesting the Governor and the Wisconsin Legislature to allow counties, by ordinance, to impose a special sales tax for the construction and operation of county jails; and

BE IT FURTHER RESOLVED, that the special sales tax shall cover both the capital costs associated with the increased use of county jails and the staffing costs incurred by a county jail in order to safely support increased jail population;

BE IT FURTHER RESOLVED, that the County Clerk be directed to send a copy of this resolution to all other counties in the State of Wisconsin, the Wisconsin Counties Association, the Governor, the Secretary of the Department of Administration, the Secretary of the Department of Corrections, and the Waupaca County legislative delegation.

WHEREAS, inmates released on probation and parole are being monitored for a longer time, causing their return to jail for violations of said probation or parole; and

WHEREAS, the above inmates cause an overcrowding of county jails; and the rate of daily cost of housing said inmates is not covered in total by the State, causing an additional fundamental burden on the County Jail Budget; and

WHEREAS, this should be reimbursed at the full cost of housing inmates for state probation and parole violations and not be an unfunded mandate required to be paid by county taxpayers.

NOW, THEREFORE, BE IT RESOLVED, that the Waupaca County Board of Supervisors does hereby request the Governor and the Wisconsin Legislature to provide sufficient funding to support the implementation of state policies when they result in additional costs to county taxpayers for housing probation and parole violation inmates in county jails.

BE IT FURTHER RESOLVED by the Waupaca County Board of Supervisors that the state funding shall cover both the capital costs associated with the increased use of county jails and the staffing costs incurred by a jail facility in order to safely support increased jail population.

BE IT FURTHER RESOLVED by the Waupaca County Board of Supervisors that the County Clerk be directed to send a copy of this resolution to all Wisconsin Counties, Governor Scott McCallum, the Secretary of the Department of Administration, the Secretary of the Department of Corrections, and Legislators representing constituents of Waupaca County.

RESOLUTION NO. 11 (2001-2002)

SUBJECT: Farm Crisis

WHEREAS, the total number of farms in Wisconsin has declined from 93,000 to 78,000 between 1980 and 1999; and

WHEREAS, the number of dairy farms in Wisconsin has declined from 45,000 to 22,000 between 1980 and 1999; and

WHEREAS, the acreage of farmland in Wisconsin has declined from 18.6 million acres in 1980 to 16.3 million acres in 1999, a 12.4% decline; and

WHEREAS, 56,000 acres of farmland are lost in Wisconsin every year; and

WHEREAS, prices received by Wisconsin's farmers for products such as corn and soybeans has declined or remained stagnant for several years; and

WHEREAS, prices received by Wisconsin's dairy farmers are lower than the national average and are kept artificially low by the Northeast Dairy Compact; and

WHEREAS, the value of livestock and their products, poultry and their products, and dairy products sold in Wisconsin declined by 5% between 1992 and 1995; and

WHEREAS, young people from rural areas are moving off farms in increasing numbers; and

WHEREAS, the Federal and State Government have not taken proactive steps to resolve these problems;

NOW, THEREFORE, BE IT RESOLVED, that because of the decreasing percentage of the consumer dollar received by the farmer, we ask that a special committee of the State of Wisconsin and the Federal Government should be formed to investigate as to why our farmers are receiving less than ten percent of the consumer's dollar for farm products; and

NOW, THEREFORE, BE IT RESOLVED, that Waupaca County is declaring agriculture to be in a state of crisis in the State of Wisconsin.

RESOLUTION NO. 12 (2001-2001)

SUBJECT: Waupaca County's "Conceptual" Comprehensive Planning (Smart Growth) Process Plan

WHEREAS, 1999 Wisconsin Act 9 and Wisconsin Statutes 66.1001 requires that in order for governmental units to have a voice in any land use decision after the year 2010, they must have adopted a "comprehensive plan" and have "ordinance updates and other tools" in place to implement the plan by that year; and

WHEREAS, a number of local units of government in Waupaca County have inquired about what Waupaca County will be doing to meet the requirements of the state comprehensive planning; and

WHEREAS, Waupaca County appointed a "Smart Growth Planning Process Committee" to investigate options on how to conduct the planning effort and recommend a specific process and time frame to the Waupaca County Board for their consideration; and

WHEREAS, the Waupaca County Smart Growth Planning Process Committee identified among others, the following "core values" to guide the Waupaca County's comprehensive planning effort:

- All Waupaca County units of government should work together
- Waupaca County should provide overall leadership
- Waupaca County should provide a portion of the funding
- Elected officials and local residents should be informed about comprehensive planning; and

WHEREAS, after considerable research, study, discussion, and debate, the Waupaca County Smart Growth Planning Process Committee has come forth with a recommendation for Waupaca County Board consideration; and

WHEREAS, the Waupaca County Planning and Zoning Committee endorses the overall "concept" that has been recommended by the Waupaca County Smart Growth Planning Process Committee.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors does hereby endorse the "concept" of how Waupaca County would prefer to address comprehensive planning to include:

- Waupaca County conduct a "combined/simultaneous" planning effort with all towns, villages, and cities within the county
- Waupaca County provide the overall leadership for this effort; preparing a state grant application for the fall 2002 grant deadline; with expectations that the comprehensive planning effort would begin in 2003 and be completed in 2006
- Waupaca County will update its ordinances and other tools to implement the comprehensive plan between 2007 and 2010
- Waupaca County will utilize a consultant, support from the Waupaca County Economic Development Corporation, and/or others to prepare the comprehensive planning grant application
- Waupaca County will employ a "county planner" as part of the grant request to coordinate and facilitate this planning effort between local units of government, the county, and an anticipated consultant who would prepare the actual comprehensive plan
- Waupaca County will cost share twenty five (25%) of the comprehensive planning costs; anticipating twenty five (25%) to come from other Waupaca County local units of government and fifty (50%) from a state comprehensive planning grant
- Waupaca County will postpone the anticipated time schedule, including the employment of a "county planner" and development of the comprehensive plan, if

Waupaca County does not receive a comprehensive planning grant from the state in 2002.

BE IT FURTHER RESOLVED that this "conceptual proposal" will be presented to all Waupaca County towns, villages, and cities to garner their comment, consideration and eventual endorsement via an intergovernmental agreement during the time frame from the date of adoption of this resolution through September 1, 2001, and

BE IT FURTHER RESOLVED that this "conceptual proposal" will receive further review through the Waupaca County Planning and Zoning Committee and the Finance Committee to the Waupaca County Board for consideration as part of the 2002 budget deliberations.

WHEREAS, the Waupaca County Jail currently does not have an inmate healthcare program; and

WHEREAS, the existing jail lacks any facility for examination and treatment of inmates the new jail has incorporated a medical area on the second floor; and

WHEREAS, jail populations are at above average risk of contracting communicable diseases such as TB, HIV and hepatitis thus necessitating the need for health services; and

WHEREAS, health care services provided on-site is more effective than transporting to local clinic and emergency rooms; and

WHEREAS, the early transition to the new jail necessitates that the on-site health service be started early; and

WHEREAS, surplus funds resulting from anticipated savings on the jail food service will cover the estimated cost of an early transition (a cost that was not anticipated or budgeted).

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors does hereby authorize the advancing the commencement date for the start of on-site health care services to August 1, 2001 to accommodate the transition to the new jail.
