REPORT NO. 9 (2001-2002) Economics of Tourism

Terri Schultz, Waupaca Area Chamber of Commerce and Jennifer Allyn, New London Area Chamber of Commerce. Over \$69 million is being brought into Waupaca County from tourists. This creates over 2,135 full-time equivalent jobs in the county and traveler expenditures supports 1,793 jobs which equates to over \$28 million in wages, salaries and proprietary income into the county. The ½% Waupaca County sales tax generated by tourism is \$320,000. The Waupaca County Visitors and Promotion Council encouraged the County Board to use the county sales tax dollars generated by tourists to maintain and expand county public recreations facilities, such as parks, trails, boat landing, forests, etc. The report will be filed and become part of the minutes.

REPORT NO. 10 (2001-2002) Health & Human Services 2000 Annual Report Dennis Dornfeld, Director

Dennis Dornfeld summarized the annual report. Approximately 20% of the Waupaca County population is touched by the Department of Health and Human Services in any given year. Dennis reviewed the highlights of 2000. A major concern of the Health & Human Services board is the waiting list for services. The report will be filed and become part of the minutes.

Supr. Hurlbut thanked everyone who was involved with the open house of the Law Enforcement Center. Chairman Brown thank Supr. Hurlbut and Sheriff Liebe for their good job on the dedication. Chairman Brown also thanked the Special Building Committee for attending all the meetings they had since 1996, and thanked the entire County Board for the good job they have done over the years working together and compromising on decisions.

Supr. Rasmussen purchased two old Waupaca County Asylum potato burlap bags, which he had framed. One will be displayed at Lakeview Manor and the other will be on display in the County Board Room.
