# WAUPACA COUNTY BOARD OF SUPERVISORS ANNUAL SESSION NOVEMBER 20, 2001

County Board Chair Brown called the meeting to order at 9:00 a.m. with 26 members present.

Supr. Barrington excused.

County Board Chair Brown made the opening statement that this meeting and all other meetings of this board are open to the public. Proper notice has been posted and given to the press, in accordance with Wisconsin Statutes so the citizenry may be aware of the time, place and agenda of this meeting.

Pledge of Allegiance was said by all followed by a moment of silence.

Supr. Flink moved and Supr. Whitman seconded the motion to approve the agenda. Motion carried 26-0.

Supr. Rasmussen moved and Supr. Mares seconded the motion to approve the minutes from the October 30, 2001 meeting. Motion carried 26-0.

#### **HONOR PRESENTION – SHERIFF'S DEPARTMENT**

Barbara Mehlberg responded to a call of a possible drowning on Casey Lake and was able to start CPR on an elderly subject as soon as he had been removed from the water by Lisa Ross. As a result of Barbara Mehlberg starting and maintain CPR until the ambulance arrived, the victim was revived. Sheriff Liebe presented Barbara Mehlberg (present) and Lisa Ross with a certificate citing their willingness to go above and beyond for others. The Waupaca County Sheriff's Office recognizes Barbara Mehlberg and Lisa Ross as an example of citizenship's worthy emulation by us all.

## WISCONSIN COUNTY MUTUAL John Dirske

Executive Vice President John Dirske of Wisconsin County Mutual updated the County Board on what the organization has been doing. A dividend check in the amount of \$63,592 was presented to Chair Duane Brown.

# PUBLIC HEARING FOR THE 2002 BUDGET AND TRANSPORTATION SERVICES PROGRAM 85.21

Finance Director Jim Bernhagen reported that Finance and Personnel Committee met on November 14, 2001 approved a .75 full-time equivalent clerk typist position with the cost off set by an increase in the Register of Deeds fees revenue account. This change would have no impact on the proposed operating budget tax levy. The committee approved to remove \$603,551 in proposed costs associated with highway construction projects. This was made possible because the County Board of Supervisors authorized the borrowing of \$5 million to fund the capital improvement program. The Finance Department has made the necessary corrections to the year 2002 operating, special purpose and debt service budget. The operating budget mill rate is now at \$4.23, special purpose mill rate is \$.26, and debt service mill rate is \$.98. The combined mill rate with the changes that the Finance Committee made is now \$5.47.

Chair Brown opened the public hearing and asked if anyone would like to speak on the budget.

Nancy Camber, E1427 Nelson Road, Iola, expressed her concerns about a newspaper article stating that there is an increase of 19.96% in property taxes. Finance Director Bernhagen explained that this increase was in the general fund tax levy. Overall, the tax levy increase now is only 4.48%.

Chair Brown called 3 times for any public input. Being no other input, Supr. Flease moved and Supr. Arndt seconded the motion to close the public hearing and reconvene into regular session. Motion carried 26-0.

#### **COMMITTEE REPORTS**

Supr. Loughrin, Chair of the Finance Committee, thanked the Committee, Jim Bernhagen for organizing the budget session and all his helpful advice, and the department heads and committees for preparing their department budgets. Many difficult decisions had to be made and the Committee did not always agree. Everyone was looking out for their own priorities—the County. To stay under the revenue cap, it forced some of the capital projects out of the operating budget. We presented a capital project funding project to the County Board on October 30, 2001 and it was approved. Now the highway improvement program is on track with the long-range plan and long needed projects at the Fairgrounds. Supr. Loughrin thanked the County Board for their approval.

Supr. Flease commented on the closing of the local DMV service stations due to budgetary constraints. Closing of the local DMV offices would be inconvenient for many Waupaca County residents. Supr. Flease suggested that the County Board pass a resolution stating the County's displeasure of this move. Sheriff Liebe stated that he has written several letters to the DOT discouraging the closure of the facilities. Chairman Brown has referred the matter to the Legislative and Judicial Committee.

### **RESOLUTION NO. 39 (2001-2002)**

# SUBJECT: JURISDICTIONAL TRANSFER - County Trunk Highway "CC"

WHEREAS, Waupaca County agrees to release to the Township of Matteson maintenance, jurisdiction and ownership of underlying right of way for a segment of roadway described in the attached Jurisdictional Transfer Agreement.

NOW, THEREFORE, BE IT RESOLVED that Waupaca County transfer maintenance, jurisdiction and ownership of CTH "CC" to the Town of Matteson.

BE IT FURTHER RESOLVED, that the Jurisdictional Transfer will become effective upon the acceptance of this transfer by the Waupaca County Chairman.

WHEREAS, one or more County depository is required to be designated as "working bank" under Section 59.74, Wisconsin Statutes. Farmers State Bank has been so designated to carry the account for the period January 1, 2002 to December 31, 2004; with an annual renewal option.

**WHEREAS**, the County of Waupaca participates in the State of Wisconsin's Local Government Pooled Investment fund pursuant to the provisions of Section 25.50 of Wisconsin Statutes; and

WHEREAS, deposits in banks, savings and loan associations, and credit unions which are state and federally chartered and are located in Waupaca County, the State of Wisconsin Local Government Pool, the AIM Fund, the purchase of bonds or securities issued or guaranteed as to principal and interest by the federal government, or by a commission, board or other instrumentality of the federal government, qualify for the public deposit of County funds not immediately needed under authority granted by Section 59.75 and Section 66.04(2), Wisconsin Statutes; and

**WHEREAS,** A.G. Edwards & Sons, Inc., has been designated as Waupaca County Investment Advisors.

**NOW, THEREFORE, BE IT RESOLVED** that the Waupaca County Board of Supervisors hereby designates all those banks, savings banks and credit unions chartered under state and federal law and located in Waupaca County, State of Wisconsin's Local Government Pooled Investment Fund, the AIM Fund and Dana Investment Advisors, Inc. as County depositories.

**BE IT FURTHER RESOLVED** that the County Treasurer advise the Finance Committee each month of the total amount as required by Waupaca County Ordinance #4.04(4); and

**BE IT FURTHER RESOLVED** that the Waupaca County Treasurer secures investments in excess of \$500,000.00 covered by the appropriate Federal Insurance and the State of Wisconsin, per 1985 Wisconsin Act 25, with securities of the U.S. Treasury, Agencies, Certificates of Deposit drawn on a Federal Home Loan Bank <u>or a Bank Deposit Guarantee Bond</u>, and that <u>pledged</u> securities or <u>deposit insurance</u> have a cumulative face value totaling minimum of 110% of the invested amounts over the aforementioned \$500,000.00 secured by the appropriate Federal Insurance and Wisconsin Act 25; and
