- 1. Provide for the continuation of a self-insured worker's compensation program that is currently in effect.

WHEREAS, the 2001-03 Biennial Budget increased the landfill tipping fee surcharge from \$0.30 per ton to \$3.00 per ton and designated this revenue to be placed in the Segregated Recycling Fund; and

WHEREAS, the State of Wisconsin Joint Committee on Finance on October 9, 2002, authorized the removal of \$1 million from the Segregated Recycling Fund to finance the Department of Natural Resources' (DNR) programs on Chronic Wasting Disease for deer; and

WHEREAS, the Wisconsin County Solid Waste Management Association Board unanimously adopted a resolution opposing the transfer of monies from the Segregated Recycling Fund to the Chronic Wasting Disease programs of the DNR;

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Solid Waste Management Board opposes the transfer of monies from the Segregated Recycling Fund to the Chronic Wasting Disease programs of the DNR and considers this a misrepresentation of the landfill tipping fee surcharge's purpose for which it was intended; and

BE IT FURTHER RESOLVED that the Waupaca County Solid Waste Management Board opposes all non-recycling related uses of the Segregated Recycling Fund and considers such uses to be irresponsible fiscal policy and a misuse of public funds.

RE: HIPAA—The newest can't say law

You may have noticed that within the last month, doctors, clinics and other health professionals are now providing Notice of Privacy Rights to patients. This is due to the newest HIPAA (Health Insurance Portability and Accountability Act of 1996) law. A fact sheet regarding HIPAA is attached hereto for your review. The first phase of HIPAA (the privacy regulations) became effective April 14, 2003.

The county departments have for about a year and a half been working on developing and clarifying the various departments internal policies and procedures for the County overall and for those departments that deal daily with personal health information.

With the County Board Committees (Personnel Committee for example) any information concerning health conditions must be de-identified so that the information is not disclosed and the committees will be limited in the information available to them. Committees may be left to make decisions with less information than was available in the past.

Please keep in mind that when dealing with this issue, failure to protect and keep confidential the personal health information carries severe criminal and civil penalties as high as 10 years in prison and/or \$250,000 in fines.

If you have any questions regarding HIPAA issues, feel free to contact me.
