AMENDMENT TO CHAPTER NO. 34 Town of Caledonia, A-G to R-M Campground 2003-471 Z-6-03

Parcel #02-07-51-5, Z-6-03, Weiland's Landing LLC (c/o Scott J. Weiland) in Sec. 7, Town of Caledonia for a Zoning Map Amendment from an A-G (General Agriculture) zone to an R-M (Residential Multi-Family) zone for the creation of a manufactured home park on approximately 10 acres and for a Conditional Use Permit application for the expansion of a campground on approximately 39 acres in an F-P (Floodplain) zone, an O-N (Natural Resource Preservation) zone and an A-G (General Agriculture) zone.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 7, Town of Caledonia, lying along Weiland Road, Fire Number E-7584, Waupaca County, Wisconsin, on approximately 10 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Caledonia Township, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an A-G (General Agriculture) zone to an R-M (Residential Multi-Family) zone.
- Section 2. This ordinance shall be in full force and effect in the Town of Caledonia upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

RESOLUTION NO. 21 (2003-2004)

SUBJECT: The Health and Human Services Board recommends the Department continue to administer the Wisconsin Works (W-2) program for Waupaca County residents in the years 2004 and 2005.

WHEREAS, on July 16, 1996, the Waupaca County Board of Supervisors authorized the first contract with the State of Wisconsin for the department to provide W-2 services for Waupaca County, by resolution # 22 (1996-1997), the second contract on May 18, 1999, by resolution # 4 (1999-2000) and the third contract on April 17, 2001, by resolution # 1 (2001-2002) for the 2002-2003 service year; and,

WHEREAS, the Health and Human Services Department has again received from the State of Wisconsin a letter congratulating our W-2 Agency of earning the "Right of First Selection" by meeting both the program and financial criteria required in the current contract (2002-2003); and,

WHEREAS, program expenses associated with the W-2 Agency have been fully funded by the State of Wisconsin, and in addition, Waupaca County has gained some financial incentives under previous contracts to benefit local children and family services and the county; and,

WHEREAS, the projected budget figures received from the State for the next two contract years (2004 & 2005) appear very challenging with reductions in allocations over each of the two years; and,

WHEREAS, when considering the alternatives, not entering a contract with the State for W-2 services will bring even greater financial/program challenges for our department and increased disruption of customer services.

NOW, THEREFORE, LET IT BE RESOLVED, that the Waupaca County Board of Supervisors authorizes the Department of Health and Human Services to submit a plan to enter a two year contract agreement (2004 & 2005) with the State of Wisconsin to continue to administer the W-2 program.

BE IT FURTHER RESOLVED, that the administration of W-2 Agency past December 31, 2005, will require Health and Human Services Board and the full county board approval.
