WAUPACA COUNTY BOARD OF SUPERVISORS ADJOURNED ORGANIZATIONAL SESSION OCTOBER 28, 2003

County Board Chair Brown called the meeting to order at 9:00 a.m. with 25 members present.

County Board Chair Brown made the opening statement that this meeting and all other meetings of this board are open to the public. Proper notice has been posted and given to the press, in accordance with Wisconsin Statutes so the citizenry may be aware of the time, place and agenda of this meeting.

Pledge of Allegiance was said by all followed by a moment of silence.

Supr. Flink moved and Supr. Steenbock seconded the motion to approve the agenda as amended. Resolution No. 35 will be acted upon immediately following the appearance by Carlson-Dettman Consultants. Motion carried 24-0 with Supr. Allen out of the room.

Supr. Rasmussen moved and Supr. Mares seconded the motion to approve the minutes from the September 23, 2003 meeting. Motion carried 25-0.

NON-REPRESENTED EMPLOYEE SALARY STUDY

Personnel Coordinator Mandy Welch introduced Charlie Carlson of Carlson-Dettmann. Charlie Dettmann explained the salary study and the appeal process.

RESOLUTION NO. 35 (2003-2004)

SUBJECT: Non-Represented Employee Salaries for 2004 and Adoption of the Recommendations of the Classification and Compensation Study.

WHEREAS, several concerns were identified in 2001 regarding non-represented salaries including, but not limited to, the following items:

- 47% of non-represented positions were more than 5% out of comparable salary range and 26% of positions were more than 10% out of comparable salary range.
- Increasing difficulty in recruiting qualified individuals to fill management and supervisory positions.
- Pay compression issues between supervisors and union employees.
- Increasing numbers of non-represented reclassification requests.

WHEREAS, the Waupaca County Finance and Personnel Committee retained, with funds budgeted in 2002 and 2003, the firm of Carlson Dettmann Consultants to study the salaries paid to non-represented employees and to make recommendations for a new pay plan; and

WHEREAS, a new pay plan structure for non-represented employees has been recommended for 2004 (attached); and

WHEREAS, the implementation procedure for the new salary structure would involve non-represented employees receiving a 2% across the board increase and then moving to the step in the new grade for their position which provides for an increase; and

WHEREAS, it has been determined that implementation of a new classification and compensation structure will address existing concerns while providing for a cost effective method of transition to the new pay structure;

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors does hereby approve the 2004 Non-Represented Pay Structure, including the implementation process of authorizing a 2% (two percent) salary increase for all non-represented county employees effective January 1, 2004.

AMENDMENT TO WAUPACA COUNTY CODE OF ORDINANCES CHAPTER 7

This Amendment becomes effective upon passage by the Waupaca County Board of Supervisors.

WHEREAS, our County has a waiting list for developmentally disabled children and adults requiring case management and community services; and

WHEREAS, in addition, the State is currently requesting counties across the state to provide case management services for all children diagnosed with autism; and

WHEREAS, the funding required to pay for the new Social Worker will come from Medical Assistance and other federal programs funds; and

WHEREAS, our Department will provide comprehensive and coordinated services for our Waupaca County residents under this plan.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors authorizes the Health and Human Services Department to hire, effective January 1, 2004, a full-time Social Worker I or II, Labor Grade Level 8 or 9, to provide the case management services.

BE IT FURTHER RESOLVED that the funding needed to pay for this position will be fully collected from the case management and administrative funding for program services provided with no new county funding required.

RESOLUTION NO. 38 (2003-2004)

SUBJECT: The Health and Human Services Board recommends the Department create five (5) new full-time positions and eliminate, effective January 1, 2004, our current contract for five staff employed by Lutheran Social Services (LSS).

WHEREAS, the Department has been contracting with LSS for the past 20 plus years to provide primarily social worker and other children and family services in the community; and,

WHEREAS, our Department has been very satisfied with the quality of services provided by LSS over these years; and,

WHEREAS, planning for our 2004 budget with "0" increase in tax levy revenues requires creative alternatives to maintain and not reduce services to our county residents; and,

WHEREAS, our Department projects that by replacing the five full-time staff currently in contract with LSS, our Department will reduce our 2004 expense for the position services by approximately \$35,691.00; and,

WHEREAS, our Department's proposed overall 2004 Budget maintained the recommended "0" increase in county tax levy revenues by creating alternatives such as proposed in this resolution.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors authorizes the Health and Human Services Department to add the following five (5) new full-time positions to the organizational chart under the Children and Families Division in the 2004 budget: Three (3) Social Worker I & II positions, Labor Grades 8 & 9; One (1) Children Family Aide position, Professional Labor Grade 5; and One (1) Support Services Specialist position, Professional Labor Grade 6.

BE IT FURTHER RESOLVED that no new county dollars would be required to fund these positions.
