AMENDMENT TO CHAPTER NO. 34 Town of Fremont, R-M to C-G, RM-P12 2003-476, Z-11-03

Parcels #06-30-73-4, #06-30-73-75 & #06-30-73-76, Z-11-03, WestCor Development, Inc. in Sec. 30, Town of Fremont for a Zoning Map Amendment from an R-M (Residential Multi-Family) zone to a C-G (General Commercial) zone with a Conditional Use Permit application for a drive-in restaurant, motels and/or wholesaling establishments, making the zoning more consistent with the adjoining property, and also to an RM-P12 (Residential Multi-Family Planned Development, 12 Dwelling Units Per Acre Maximum) zone to allow for a greater number of dwelling units per acre.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located on Lots #4, #75 and #76 of Grey Goose Landing and being in part of the SW 1/4 of the SE 1/4 of Sec. 30, Town of Fremont, lying south off of State Highway "96" (Old State Highway "10"), Waupaca County, Wisconsin, on approximately 3.63 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Fremont Township, Detail Map B-24, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an R-M (Residential Multi-Family) zone to a C-G (General Commercial) zone and an RM-P12 (Residential Multi-Family Planned Development, 12 Dwelling Units Per Acre Maximum) zone.
 - Section 2. This ordinance shall be in full force and effect in the Town of Fremont upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

RESOLUTION NO. 42 (2003-2004)

SUBJECT: Separate, dedicated, and permanent funding source for invasive aquatic species.

WHEREAS, there are over 15,000 lakes and 32,000 miles of fresh water rivers and streams and numerous public wetlands within the State of Wisconsin; and

WHEREAS, these fresh water resources belong to all citizens of the State as guaranteed by the State Constitution and affirmed by numerous court rulings; and

WHEREAS, these water resources are the backbone of Wisconsin's \$11.7 billion tourist industry, which ranks as the third largest industry in the state; and

WHEREAS, the invasion of exotic aquatic species of plant and animal life have detrimentally impacted a significant percentage of the State's water resources, thereby reducing their quality, desirability and ability to provide recreational, economic, subsistence, and cultural opportunities; and

WHEREAS, the Public Trust Doctrine mandates that the State of Wisconsin has the responsibility for protecting these public water resources for its citizens.

NOW, THEREFORE, LET IT BE RESOLVED, that the Legislature of the State of Wisconsin exercise its legal responsibility by establishing a separate, dedicated, and permanent funding source and aggressive polices for research, prevention, best management practices, and public education for currently identified and future exotic aquatic plant and animal species in the State's water resources.

RESOLUTION NO. 44 (2003-2004)

Subject: Resolution Opposing Senate Bill 272/Assembly Bill 588

WHEREAS, under current Wisconsin law (1993 Act 496) and federal law (1996 Federal Telecommunications Act 1996) local units of government are allowed to supply competitive telecommunications services to their communities; and

WHEREAS, to date, 24 Wisconsin communities have applied for and been granted Competitive Local Exchange Carrier (CLEC) status from the Public Service Commission of Wisconsin; and

WHEREAS, most major telecommunications companies are investing their resources primarily in urban markets while rural, non-urban, smaller communities are not receiving the advanced telecom services needed to sustain economic viability; and

WHEREAS, local governmental leaders are primarily responsible for the economic development well-being of their respective communities, and

WHEREAS, Senate Bill 272 and Assembly Bill 588 place unnecessary restrictions and barriers to local governments that desire to offer advanced telecom services to their businesses and residents, thus hinder the deployment of broadband services in Wisconsin.

NOW, THEREFORE, LET IT BE RESOLVED that the County Board of Waupaca County strongly opposes SB272/AB588 and urges the State Legislature to defeat these efforts by incumbent cable television and telecommunications companies to limit the deployment of competitive advanced telecom services including cable television, broadband and local telephone services by local units of government; and

BE IT FURTHER RESOLVED that the County Board of Waupaca County joins the league of Wisconsin Municipalities, the Wisconsin Alliance of Cities, the Wisconsin Counties Association, the Municipal Electric Utilities of Wisconsin, the Wisconsin Towns Association, the Citizens Utility Board, the Wisconsin Association of School Boards, the Regional Telecommunications Commission and the North Shore Cable Commission in opposition to any efforts to limit, inhibit, or prohibit local governments from providing competitive advanced telecommunications services, and have the County Clerk forward a copy of this Resolution to all Waupaca County Legislators.
