AMENDMENT TO CHAPTER NO. 34 Town of Waupaca, A-G to RS-20 2004-480 Z-4-04

Parcels #20-31-41-2, #20-31-41-3, #20-31-41-4 & #20-32-33-2, Z-4-04, Jon M. & Amber M. Petersen, in Sections 31 & 32, Town of Waupaca for a Zoning Map Amendment from an A-G (General Agriculture) zone to an RS-20 (Residential Single-Family, 20,000 Sq. Ft. Lot Minimum) zone for a future residential subdivision.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the E ½ of the SE ¼ of Sec. 31 and also being in part of the W ½ of the SW ¼ of Sec. 32, Town of Waupaca, lying along County Highway "E", Fire Number N-2597, Waupaca County, Wisconsin, on approximately 45.7 acres.

The Zoning Map entitled Waupaca Township, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an A-G (General Agriculture) zone to an RS-20 (Residential Single-Family, 20,000 Sq. Ft. Lot Minimum) zone.

This ordinance shall be in full force and effect in the Town of Waupaca upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.

RESOLUTION NO. 11 (2004-2005)

Subject: Authorizing Waupaca County Treasurer to act as agent for the collection of taxes assessed by Municipalities.

WHEREAS, the Waupaca County Treasurer has been approached by Waupaca County municipalities to act as the collection agent for Real Estate and Personal Property Taxes; and

WHEREAS, the County is equipped and has the programming to handle the collection; and

WHEREAS, this type of agreement is in place in many Wisconsin Counties, it is requested that the County Board of Supervisors give formal approval to the County Treasurer to act as collection agent for municipalities for the purpose of collection of real estate and personal property taxes, special assessments and charges, all under the direction of the Finance & Personnel Committee; and

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Waupaca County Treasurer may at his/her discretion, enter into a written agreement under the provisions of Sec. 66.30(2) Wis. Stats. With any municipality in Waupaca County for the collection of real estate and personal property taxes, special assessments and charges.
- 2. The agreement shall continue in force until either Waupaca County or the municipality gives notice of intention to terminate and withdraw from the agreement by July 1^{st} of the tax year.
- 3. There will be no direct charge to the municipality for this service, however in consideration for these services the County will bank the collections; including interest earnings and will complete the January and February settlements.
- 4. The Finance & Personnel Committee may approve a standard form agreement, which the County Treasurer may enter into with any municipality without further authorization from the Finance & Personnel Committee. However, any deviation from the standard form contract as authorized by the Finance & Personnel shall require separate specific approval by the same committee.
- 5. The municipality desiring the services of the Waupaca County Treasurer for the collection of taxes is required to pass a resolution authorizing Waupaca County to act as its agent in the collection of taxes and to enter into an agreement in the form authorized by the Finance & Personnel Committee.

RESOLUTION NO. 12 (2004-2005)

SUBJECT: The Health and Human Services Board recommends revising the qualifications of the vacant non-represented fulltime OTS/CSP Manager position (Salary Grade L) to Psychologist and Mental Health Care Manager (Salary Grade N).

WHEREAS, our department has been unable to fill the vacant position of OT/CSP Manager for almost six months; and,

WHEREAS, revising the qualifications to a licensed-eligible or licensed psychologist should improve recruitment opportunities, as well as expand the medical/biological knowledge for improved customer services; and,

WHEREAS, having a psychologist available five days a week for staff consultation will be extremely valuable when considering a majority of our customers are treated with psychotropic medications and suffer from numerous medical/neurological conditions.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors approves the Health and Human Services Department revise the qualifications of the vacant fulltime OTS/CSP Manager position (Grade L) to Psychologist and Mental Health Care Manager (Grade N).

BE IT FURTHER RESOLVED that our 2004 budget will be revised internally to accommodate the needed additional dollars to cover the increased expense of this position change.

AND, BE IT FURTHER RESOLVED that the increased dollars required to fund this change will not require any new county dollars.
