### AMENDMENT TO CHAPTER NO. 34 Town of Caledonia, RS-20 to C-G 2004-482, Z-06-04

Parcel #02-26-12-19, Z-6-04, Robert & June Krull, in Sec. 26, Town of Caledonia for a Zoning Map Amendment from an RS-20 (Residential Single-Family, 20,000 Sq. Ft. Lot Minimum) zone

to a C-G (General Commercial) zone for a service business with a Conditional Use Permit application for storage units.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of NW 1/4 of the NE 1/4 of Sec. 26, Town of Caledonia, lying along County Highway "W", Fire Number #-9116, Waupaca County, Wisconsin, on approximately 1.95 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Caledonia Township, Detail Map B-28, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an RS-20 (Residential Single-Family, 20,000 Sq. Ft. Lot Minimum) zone to a C-G (General Commercial) zone.
- Section 2. This ordinance shall be in full force and effect in the town of Caledonia upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed with ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

#### **RESOLUTION NO. 32 (2004-2005)**

**SUBJECT:** The Health and Human Services Board recommends the Department submit a proposal for a grant to the State of Wisconsin for implementation of an Aging and Disability Resource Center in Waupaca County.

**WHEREAS,** a significant element of long-term care reform nationally and in Wisconsin has been the development of the Aging and Disability Resource Center (ADRC) as a "one-stop"

customer service center for information, advice and seamless access to opportunities, resources and public programs for people who are elderly or living with disabilities; and

**WHEREAS**, the State of Wisconsin has issued a request for proposals to fund five (5) new ADRC's in Wisconsin starting in 2005; and

**WHEREAS**, department staff have been discussing with Outagamie and Calumet counties a collaborated approach and proposal to provide access, information, and referral services through the United Way 211 system as part of an ADRC; and

WHEREAS, an ADRC would be a very positive step for Waupaca County to provide public education and outreach, information and assistance, long-term care options counseling, short-term assistance or case management, prevention programs, elderly and disability benefits specialist, administration of long-term care functional screen, administration of the mental health/AODA functional screen, and linkages to Medicaid and Medicaid waiver financial eligibility; and

**WHEREAS**, all target groups will be served by the ADRC starting the first year of full implementation with the collaboration across all county agencies; and

**WHEREAS**, after the initial funding year of \$55,000.00 for our collaboration, Waupaca County will receive a maximum of \$154,870.00 to operate an ADRC.

**NOW, THEREFORE, LET IT BE RESOLVED** that the Waupaca County Board of Supervisors authorizes the Health and Human Services Department to submit a proposal for a grant to the State of Wisconsin for implementation of an Aging and Disability Resource Center in Waupaca County.

**BE IT FUTHER RESOLVED** that the funding required for Waupaca County's contribution toward the grant comes from existing resources currently budgeted in the approved 2005 department budget proposal.
