An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the NW ¼ of the SW ¼ of Sec. 10, Town of Helvetia, lying along Valley Road, Waupaca County, Wisconsin, on approximately 5.02 acres.

AMEND CHAPTER 7.07 OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: WEIGHT RESTRICTION - County Trunk Highway "F" (Pine Street) From United States Highway 10 North To Alfred Street

WHEREAS, Wisconsin Statutes 349.15(2), relative to the authority to modify weight limitations and classify highways, gives the County Highway Committee authority to designate all or parts of such highways maintained by them to be Class "B" highways for the purpose of putting into effect the weight limitations set forth in Section 348.16(2) (3); and

WHEREAS, the imposition of weight limits can be based on weakness of the roadbed due to deterioration or climatic conditions or other special conditions, and the potential for serious damage or destruction in the absence of such weight restrictions; and

WHEREAS, the Highway Committee and Highway Commissioner have reviewed and considered the implications of adopting an ordinance by submitting this county trunk highway to the County Board; and

WHEREAS, proper signing will be enacted in accordance with Wisconsin Statute 349.16 (2) and the authority in charge of maintenance may exempt vehicles carrying certain commodities specified by the authority, including but not limited to pumping septic or holding tanks, from the special weight limitations which are imposed under sub. (1) (a); and

WHEREAS, weight limitations on Class "B" highways Wisconsin Statute 348.16(2) state, pursuant to s.349.15 (3) "No person without a permit therefore shall operate any vehicle or combination of vehicles imposing wheel, axle, group of axles, or gross weight on the highway exceeding 60 percent of the weights authorized in Wisconsin Statutes 348.15 (3)," and certain highways should be class "B" to insure them as safe traffic carriers, as so designated by the Highway Committee.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain as follows:

This special ordinance shall be in force for the Waupaca County Highway Department to designate and maintain CTH "F" (Pine Street) from USH 10 north to Alfred Street as a Class "B" highway for the purpose of establishing weight limitations to preserve the roadbed and insure this road as a safe traffic carrier, and signed in accordance with Wisconsin Statute 349.16 (1)(2)(3).

CONDITIONS: No person, whether operating under a permit or otherwise, shall operate a vehicle in violation of special weight limitations imposed by local authorities on the highway designated herein when signs have been erected as required by Wisconsin Statutes 349.16 (3). The compliance with regard to the modification, designation, and signing of the county trunk highway will be in accordance with applicable Wisconsin Statutes.

This ordinance shall be effective upon passage and publication and the signing as required by Wisconsin State Statutes.

RESOLUTION NO. (2005-2006)

SUBJECT: The Health and Human Services Board recommends the Department continue to provide Wisconsin Works (W-2) Program services for Waupaca County residents and submit a proposal for contracting with the State for contract years 2006 through 2009.

WHEREAS, on July 16, 1996 the Waupaca County Board of Supervisors authorized the first contract with the State of Wisconsin and our Health and Human Services Department to provide W-2 services for Waupaca County residents; and,

WHEREAS, the Board of Supervisors has authorized three subsequent contracts with the State of Wisconsin for W-2 services that will be ending December 31, 2005; and,

WHEREAS, all program expenses associated with the operation of our W-2 Agency, for each of those contract years have been fully funded by the State of Wisconsin, and in addition, Waupaca County was awarded additional financial incentives (over \$400,000.00) under previous contracts to benefit local children and family services and the county; and,

WHEREAS, the Waupaca County W-2 budget allocation received from the State for the first two contract years (2006-07) will be very challenging due to reduced allocations; and,

WHEREAS, when considering the alternative of the Department not providing W-2 services for Waupaca County residents brings concerns: for the disruption of customer services, reduced children and family support, fragmentation of service delivery, and generally the concern for the loss of excellent quality services.

NOW, THEREFORE, LET IT BE RESOLVED, that the Waupaca County Board of Supervisors authorizes the Department of Health and Human Services to enter into a contract (2006-2009) with the State of Wisconsin to administer the local W-2 Program, either through direct contract or in collaboration with a multi-county consortium (Outagamie, Calumet, and Winnebago).

BE IT FURTHER RESOLVED, that the Health and Human Services Board shall be given the authority at any time to end the W-2 contract due to funding or other concerns associated with the delivery of W-2 services over the contract period authorized in this resolution.

RESOLUTION NO. 8 (2005-2006)

SUBJECT: Resolution relating to the closeout of the Gateway unit at Lakeview Manor.

WHEREAS, changes in the law now mandates that developmentally disabled residents placed in ICFMR facilities must be assessed to determine whether they are living in the most integrated setting for which they are capable; and

WHEREAS, Lakeview Manor, the County run nursing facility, operates a wing known as the GATEWAY UNIT which is an ICFMR unit currently housing 11 residents; and

WHEREAS, an ad hoc committee consisting of Lakeview Manor staff and Health and Human Services staff has been working for a number of months to develop a plan with the potential for relocating the 11 residents into the community; and

WHEREAS, the efforts of the ad hoc committee has resulted in a plan to effectively closeout the Gateway Unit as of December 2005.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors endorses the closeout of the Gateway Unit and authorizes the Lakeview Manor Administrator and the Department of Health and Human Services Director to proceed with the closeout and to timely and effectively relocate the developmentally disabled residents residing in the Gateway unit.
