AMEND CHAPTER 7, SEC. 7.05 C – COUNTY ROAD NAME CHANGES OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: NAME CHANGE OF COUNTY TRUNK HIGHWAY "SS"

WHEREAS, 4.61 miles of CTH "S" between CTH "C" and CTH "SS" will be transferred to the Town of Dupont in a previously approved jurisdictional transfer; and

WHEREAS, there is a remaining section of CTH "S" that continues 4.18 miles in a northeasterly direction from the CTH "SS" intersection to USH 45; and

WHEREAS, CTH "SS" continues from CTH "S" intersection 2.33 miles in a northwesterly direction to the Shawano County Line; and

WHEREAS, changing the name of CTH "SS" to CTH "S" will give continuity to the same highway.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain as follows:

Change the designation of CTH "SS" to CTH "S" from the intersection of CTH "S" northwesterly 2.33 miles to the Shawano County Line.

BE IT FURTHER RESOLVED that the change in designation to CTH "S" be effective upon erection of standard signs giving notice thereof.

ORDINANCE NO. 45 WAUPACA COUNTY CODE OF ORDINANCES

AN ORDINANCE TO ENACT THE WAUPACA COUNTY YEAR 2030 COMPREHENSIVE PLAN

The County Board of Supervisors of Waupaca County, Wisconsin, does ordain as follows:

- SECTION 1. Pursuant to section 59.69, Wisconsin Statutes, Waupaca County is authorized to prepare and adopt a comprehensive plan as defined in sections 66.1001(1)(a) and 66.1001(2), Wisconsin Statutes.
- SECTION 2. Waupaca County has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by section 66.1001(4)(a), Wisconsin Statutes.
- SECTION 3. The Waupaca County Zoning and Land Use Planning Committee, by a majority vote of the entire committee recorded in its official minutes, has adopted a resolution recommending to the County Board the adoption of the document entitled "Waupaca County Year 2030 Comprehensive Plan" containing all of the elements specified in section 66.1001(2), Wisconsin Statutes.
- SECTION 4. Waupaca County and its communities have provided numerous opportunities for public involvement in accordance with the Public Participation and Education Plan adopted by the Waupaca County Board including public informational meetings, open Plan Commission/Committee meetings, public opinion surveys, news releases, newsletters, a slogan contest, and a planning process web site. A public hearing was held on August 20th, 2007, in compliance with the requirements of Section 66.1001(4), Wisconsin Statutes.
- SECTION 5. The Waupaca County Board of Supervisors does, by the enactment of this ordinance, formally adopt the two documents composing the "Waupaca County Year 2030 Comprehensive Plan" (including the "Plan Recommendations Report" and the "Inventory and Trends Report") pursuant to Section 66.1001(4)(c), Wisconsin Statutes.
- SECTION 6. This ordinance shall take effect upon passage by a majority vote of the members-elect of the County Board and publication/posting as required by law.

RESOLUTION NO. 16 (2007-2008) RECOMMENDATION OF THE ZONING AND LAND USE PLANNING COMMITTEE TO ADOPT THE WAUPACA COUNTY YEAR 2030 COMPREHENSIVE PLAN

Adopted by the Waupaca County Zoning and Land Use Planning Committee on July 17, 2007. A copy of the entire resolution is on file in the County Clerk's Office.

RESOLUTION NO. 17 (2007-2008)

WHEREAS, since its establishment in 1978 the Private Onsite Wastewater Treatment System Replacement or Rehabilitation Financial Assistance Program, commonly referred to as the Wisconsin Fund, has awarded over \$83.2 million in grants for nearly 34,400 residences and businesses to replace or rehabilitate failing private systems statewide;

WHEREAS, the Wisconsin Fund has provided a significant local impact by awarding over \$903,000 for 400 systems in Waupaca County; and

WHEREAS, the Wisconsin Fund has become a valuable tool for Waupaca County to protect public health, safety and waters of the county by facilitating the replacement or rehabilitation of private systems as a proactive component of code enforcement; and

WHEREAS, the absence of the Wisconsin Fund would create a financial hardship for several owners of failed private systems to comply with state administrative code requirements to have said failed systems replaced or rehabilitated and will furthermore cause a financial strain on Waupaca County's ability to enforce said code requirements.

NOW THEREFORE BE IT RESOLVED THAT the Waupaca County Board of Supervisors hereby supports the preservation and funding of the Private Onsite Wastewater Treatment System Replacement or Rehabilitation Financial Assistance Program in the 2008-2010 State budget.

RESOLUTION NO. 18 (2007-2008) POLICY RELATING TO RETENTION OF WCA ANNUAL CONFERENCE DOOR PRIZES

RESOLUTION NO. 19 (2007-2008)

Subject: Resolution Supporting Change for Returning Federal Funds From Certified Public Expenditures of County Nursing Homes

WHEREAS, Waupaca County owns and operates a 50 bed skilled nursing facility that provides a safety net for a population that has difficulty securing services elsewhere because of the special and expensive care that is required; and

WHEREAS, the facility operates at a loss each year because of the difficulty and high cost of providing care, and Waupaca County has been forced to fund approximately \$1.4 million per year to supplement the facility's operating losses; and

WHEREAS, the State of Wisconsin claims those losses in reports to the federal government and received 58% matching funds to compensate for the reported losses under the Certified Public Expenditure (CPE) program; and

WHEREAS, the state of Wisconsin claimed approximately \$90,000,000 in Federal funds for state-wide governmental nursing home losses in budget years 2005-2007, and diverted these funds from counties to the State's Medicaid Trust Fund; and

WHEREAS, the State of Wisconsin decreased supplemental funding from the Intergovernmental Transfer Program (ITP) for governmental nursing homes from \$54,773,148 to \$37,100,000 and diverted \$17,673,148 from counties to the State's Medicaid Trust Fund resulting in a \$313,465 decrease in ITP funds to Lakeview Manor; and

WHEREAS, the 2007-2009 State Budget proposed by Governor Doyle estimates claiming \$77,000,000 in Federal Funds for state-wide governmental nursing home losses and diverting these funds from counties to the state's Medicaid Trust Fund.

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors does hereby support returning all federal funds received from the Certified Public Expenditures of county nursing homes be returned to the county nursing homes in order to bring direct tax relief to the citizens of Waupaca County; and

BE IT FURTHER RESOLVED THAT the County Clerk is hereby directed to send a copy of this resolution to Governor Jim Doyle, DHFS Secretary Kevin Hayden and all Waupaca County Legislators.
