Chair Koeppen called the meeting to order at 9:00 a.m. with 26 members present.

Chair Koeppen announced that Supr. Steenbock has resigned. An advertisement has been placed in the Clintonville Tribune asking if there is anyone interested in the position. Chair Koeppen will interview the applicants.

Chair Koeppen made the open meeting statement that this meeting and all other meetings of this board are open to the public. Proper notice has been posted and given to the press, in accordance with Wisconsin Statutes so the citizenry may be aware of the time, place and agenda of this meeting.

A moment of silent meditation was observed followed by the Pledge of Allegiance.

Supr. G. Murphy moved and Supr. Flink seconded the motion to approve the agenda. Motion carried 26-0.

Supr. Jonely moved and Supr. Peterson seconded the motion to approve the minutes of the previous meeting. Motion carried 26-0.

UWEX – CHANCELLOR AWARD Connie Abert, Youth Educator

Supr. Hurlbut announced that UWEX Youth Educator Connie Abert recently received the 2007 Chancellor's Award for Excellence in Civic Engagement.

WCA ANNUAL CONFERENCE October 7-9, 2007

Chair Koeppen and Supr. Sperl reported on the WCA Annual Conference.

2008 PROPOSED BUDGET Jim Bernhagen, Finance Director

Jim Bernhagen presented the proposed 2008 budget, gave a brief overview, and reviewed the Budget Summary. The Summary of Waupaca County's 2008 Proposed Operating, Special Purpose and Debt Service Budget sheet is on the following page. Chair Koeppen placed the 2008 Proposed Budget on file in its entirety in the County Clerk's Office.

Chair Koeppen called for a short recess. Chair Koeppen called the meeting to order.

COMPREHENSIVE PLANNING CONTRACT Nic Sparacio, Foth Infrastructure & Environment

Nic Sparacio explained Implementation Phase I. Each community has been given a number of what their cost share would be. The communities are in the process of looking at these numbers and passing resolutions saying that they agree with this as long as they stay within +/- 5%. The basic set-up is a cost share arrangement where there is one for each local community. There is 1/3 standard fee, 1/3 valuation base and 1/3 population base. In terms of County versus local break down, it is proposed that the County would pay 51% of the project cost and the communities would cover 49% of the project cost. The numbers will be refined and adjusted based on the specific scope by providing a range for the total project of anywhere from \$230,000 to \$280,000 over a 3-year period. The benefit of this financing approach is fairness and efficiency. Every community, every unit of government that would benefit from the process would be contributing to the cost. The contract will launch the project validation phase which would be working with staff, the core planning committee, bring the steering committee together, and continuing to work with the local communities to refine and build consensus on the specifics of the project scope. This proposal relies on 2007 funds, \$13,900 in estimated fees that would come from the existing Zoning Department budget. They have some money available for contract services. This amount would come out of the total estimated project cost. This is not in addition to the \$230,000 to \$280,000 that was proposed as a total project cost. This is already in that number. The ultimate cost of the project, if the County moves ahead with it, would be less \$14,000 approximately. Expenses and mileage are included in that estimated total.

Supr. Hurlbut moved and Supr. Kussmann seconded the motion to approve the Comprehensive Planning Contract. Motion carried 26-0. Passed the 30^{th} day of October, 2007.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the NE ¼ of the SW ¼ of Sec. 30, Town of Fremont, lying along County Highway "H", Waupaca County, Wisconsin, on approximately 15 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Fremont Township, Detail Map B-24, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an A-G (General Agriculture) zone and an F-F (Flood Fringe) zone to a C-C (Community Commercial) zone.
- Section 2. This ordinance shall be in full force and effect in the Town of Fremont upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) day with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

WHEREAS, the only reason for this recommendation is to reduce county levy dollars to reach the expected 0% levy limit for Departments.

NOW, THEREFORE, LET IT BE RESOLVED, that the Waupaca County Board of Supervisors authorizes the Health and Human Services Board to eliminate the 3.6 FTE contracted positions and create 2.5 FTE's, LGL #8 Healthy Beginnings Case Managers effective with the passage of the 2008 budget.

BE IT FURTHER RESOLVED, that the contracted funds currently in the budget will be used to cover the new county positions.
