WAUPACA COUNTY BOARD OF SUPERVISORS ADJOURNED ANNUAL SESSION March 18, 2008

Chair Koeppen called the meeting to order at 9:00 a.m. with 25 members present.

A moment of silent meditation was observed followed by the Pledge of Allegiance.

AMERICAN TRANSMISSION COMPANY David Hovde

David Hovde, Local Relations Representative for American Transmission Company, reported on the projects of American Transmission Company and the construction of the Morgan-Werner West Transmission Line. David Hovde reported that Waupaca County will receive a one-time environmental impact fee of \$536,550. Payments are based on 5% of the estimated cost of the project which was \$120 million and there is a factor for the number of miles that happen to be in each jurisdiction. The County gets 50% of that and each municipality gets a share based solely on the portion of the line that is in their jurisdiction. The funds must be used for environmental programs.

AMEND CHAPTER 7.08 OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: WEIGHT RESTRICTION - County Trunk Highway Bridge

WHEREAS, a joint inspection by Wisconsin Department of Transportation Bridge Personnel and Waupaca County Bridge Personnel, has shown that deficiencies exist on Waupaca County Bridge P-68-0081 (CTH "Q" over the Waupaca River), Town of Farmington; and

WHEREAS, these deficiencies are such that Wisconsin Department of Transportation personnel recommend that a twenty (20) ton weight limit be placed on this structure.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain that Waupaca County bridge P68-0081 (CTH "Q" over the Waupaca River), Town of Farmington be posted with a 20 ton weight limit.

CONDITIONS: No person, whether operating under a permit or otherwise, shall operate a vehicle in violation of special weight limitations imposed by local authorities on the bridge designated herein when signs have been erected as required by Wisconsin Statutes 349.16 (2). The compliance with regard to the modification, designation, and signing of the county trunk highway bridge will be in accordance with applicable Wisconsin Statutes.

This ordinance shall be effective upon passage and publication and the signing as required by Wisconsin State Statutes.

AMENDMENT TO CHAPTER NO. 34 Town of Waupaca, A-G to C-G 2008-504

Parcel #20-31-23-3, Z-1-08, St. Mary Magdalenes Congregation, in Sec. 31, Town of Waupaca for a Zoning Map Amendment from an A-G (General Agriculture) zone to a C-G (General Commercial) zone for a dental clinic.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the SW ¼ of the NW ¼ of Sec. 31, Town of Waupaca, lying at the intersection of Highway "22" and Shadow Road, Waupaca County, Wisconsin, on approximately 3.46 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Waupaca Township, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an A-G (General Agriculture) zone to a C-G (General Commercial) zone.
- Section 2. This ordinance shall be in full force and effect in the Town of Waupaca upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.
