Chair Koeppen called a recess for the committees to select committee chairs. Chair Koeppen called the meeting to order.

WAUPACA COUNTY ECONOMIC DEVELOPMENT Revolving Loan Fund Spirit Implement, LLC

Ryan Delaney of Spirit Implement, LLC reported on what the company does and is requesting \$100,000 from the Revolving Loan Fund. Spirit Implement would be hiring 38 new employees and will be building a 120,000 sq. ft. building in Waupaca's Industrial Park. Supr. Sperl moved and Supr. Flink seconded the motion to approve the \$100,000 Revolving Loan Fund to Spirit Implement, LLC. Motion carried 27-0. Passed the 16th day of April, 2008.

REPORT NO. 2 (2008-2009) Solid Waste/Recycling Program Updates Roger Holman

Roger Holman reviewed the Burning News newsletter, Open Burning & Recycling guidelines, PTF flyer, and the 2008 Solid Waste & Recycling Programs. Roger Holman announced that there will be a medication round-up at the Courthouse on April 22.

AMEND CHAPTER 2 OF THE WAUPACA COUNTY CODE OF ORDINANCES The Governing Body

Chapter 2, Rule No. 1.1 amended to read, "Meeting hours of the Board shall be 9:00 a.m. or at the discretion of the Chairperson of the County Board. The Public Hearing of the budget held on the second Tuesday in November shall be scheduled to begin at 9:00 a.m. The budget requires a simple majority to pass. Budget amendments <u>after passage of budget</u> requires a 2/3 vote of members elect."

Chapter 2, Rule 1.3 (1)(c) amended to read, "A quorum being present, the Board shall proceed to the election of Chair and Vice Chair. (See Sec. N, Election of Officers)"

Chapter 2, Rule 1.4 amended to read, "Annual Meeting: Waupaca County Board shall hold their Annual Meeting on the second Tuesday in November. This meeting shall be the Public Hearing on the Budget for the succeeding year and the 85.21 Transportation Fund. This date may be changed by a majority of the County Board of Supervisors. A simple majority to pass the budget. Amendments after passage of budget requires a 2/3 vote of the members elect."

Chapter 2, Rule 6.1 amended to read, "All budget changes or appropriations of money over and above the adopted annual budget shall be made only by the adoption of a resolution or ordinance passed in accordance with the laws of the State of Wisconsin and submitted through the Finance and Personnel Committee and requires a 2/3 vote of the members elect. Minor budgetary

transfers and changes, defined as 10 percent or less of the department's annual approved budget are controlled by the County's Finance Director."

Chapter 2, Rule No. 9 amended to read, "The County Clerk shall distribute copies of the County Board Proceedings to all department heads and all Board Members as soon as possible after each Board session."

Chapter 2, Rule No. 12.4(b) created to read, "Cancellation Policy. On any prepaid convention, conference or seminar, a supervisor must notify the County Clerk's office at least 48 hours of a cancellation or any non-reimbursable fee shall be paid from the supervisor's mileage and expense voucher."

Supr. Kussmann moved and Supr. Handrich seconded the motion to adopt the amendments to Chapter 2 of the Waupaca County Code of Ordinances. Motion carried 26-1 with Supr. Craig voting no. Passed the 16th day of April, 2008.

AMEND CHAPTER 7.07 OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: WEIGHT RESTRICTION - County Trunk Highway "W" From State Trunk Highway 96 to Beckert Road

WHEREAS, Wisconsin Statutes 349.15(2), relative to the authority to modify weight limitations and classify highways, gives the County Highway Committee authority to designate all or parts of such highways maintained by them to be Class "B" highways for the purpose of putting into effect the weight limitations set forth in Section 348.16(2) (3); and

WHEREAS, the imposition of weight limits can be based on weakness of the roadbed due to deterioration or climatic conditions or other special conditions, and the potential for serious damage or destruction in the absence of such weight restrictions; and

WHEREAS, the Highway Committee and Highway Commissioner have reviewed and considered the implications of adopting an ordinance by submitting this county trunk highway to the County Board; and

WHEREAS, proper signing will be enacted in accordance with Wisconsin Statute 349.16 (2) and the authority in charge of maintenance may exempt vehicles carrying certain commodities specified by the authority, including but not limited to pumping septic or holding tanks, from the special weight limitations which are imposed under sub. (1) (a); and

WHEREAS, weight limitations on Class "B" highways Wisconsin Statute 348.16(2) state, pursuant to s.349.15 (3) "No person without a permit therefore shall operate any vehicle or combination of vehicles imposing wheel, axle, group of axles, or gross weight on the highway exceeding 60 per cent of the weights authorized in Wisconsin Statutes 348.15 (3)," and certain highways should be class "B" to insure them as safe traffic carriers, as so designated by the Highway Committee.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain as follows:

This special ordinance shall be in force for the Waupaca County Highway Department to designate and maintain CTH "W" from STH 96 to Beckert Road as a Class "B" highway for the purpose of establishing weight limitations to preserve the roadbed and insure this road as a safe traffic carrier, and signed in accordance with Wisconsin Statute 349.16 (1)(2)(3).

CONDITIONS: No person, whether operating under a permit or otherwise, shall operate a vehicle in violation of special weight limitations imposed by local authorities on the highway designated herein when signs have been erected as required by Wisconsin Statutes 349.16 (3). The compliance with regard to the modification, designation, and signing of the county trunk highway will be in accordance with applicable Wisconsin Statutes.

This ordinance shall be effective upon passage and publication and the signing as required by Wisconsin State Statutes.
