Chair Koeppen called the meeting to order at 9:00 a.m. with 25 members present.

AMEND CHAPTER 7.04 OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: Speed Restriction – County Trunk Highway "B"

WHEREAS, Village of Ogdensburg officials have requested that the speed limit on the following described highway be changed; and

WHEREAS, a review of the following described highway and the maximum permissible speed at which vehicles can be operated on said highway which is reasonably safe and prudent has been established pursuant to Sec. 346.57 and Sec. 349.11 of the Wisconsin Statutes.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors do hereby ordain as follows:

35 miles per hour from the west corporate limits in the Village of Ogdensburg, southeasterly 0.326 miles to its intersection with Humbolt Street in said Village.

25 miles per hour from its intersection with Humbolt Street in the Village of Ogdensburg easterly .264 miles to its intersection with CHT "E" (Water Street) and south .123 miles to its intersection with Fulton Street in said Village.

35 miles per hour from CTH "E" (Water Street) in the corporate limits in the Village of Ogdensburg, easterly 0.095 miles to its intersection with Frankfort Street in said Village.

This ordinance shall be effective upon erection of standard signs giving notice thereof.

AMEND CHAPTER 9 OF THE WAUPACA COUNTY CODE OF ORDINANCES

Supr. Jonely moved and Supr. Johnson seconded the motion to suspend the reading and approve the amendments to Chapter 9 of the Waupaca County Code of Ordinances. Motion carried 24-1 with Supr. Hipschman voting no. Passed the 20th day of July, 2010. Chapter 9 is on file in its entirety in the Waupaca County Clerk's Office.

REPEAL CHAPTER 27 IN ITS ENTIRETY AND AMEND CHAPTER 25, CONSTRUCTION AND EFFECT, OF THE WAUPACA COUNTY CODE OF ORDINANCES

Supr. Flink moved and Supr. Kussmann seconded the motion to repeal Chapter 27 in its entirety and amend Chapter 25 of the Waupaca County Code of Ordinances. Motion carried 25-0. Passed the 20th day of July, 2010. Chapter 25 is on file in its entirety in the Waupaca County Clerk's Office.

RESOLUTION NO. 18 (2010-2012)

SUBJECT: Placing Advisory Referendum Question on November Ballot

WHEREAS, according to the Legislative Fiscal Bureau, over the past decade, the State of Wisconsin has transferred approximately \$1.2 billion from the state's segregated transportation fund to the state's general fund and replaced it with approximately \$800 million in General Obligation (GO) bonds; thereby, reducing the amount available for transportation purposes by approximately \$400 million, and

WHEREAS, Wisconsin's practice of transferring money from the segregated transportation fund to the general fund has eroded the public's confidence that the "user fees" they pay through the state gasoline tax and vehicle registration fees will be used for their intended purpose; and

WHEREAS, Wisconsin's practice of replacing the dollars transferred from the state's segregated transportation fund with GO bonds puts out state in the precarious position of bonding to fund ongoing operations; and

WHEREAS, the Pew Center on the States recently released a report that included Wisconsin as having one of the ten worst budget situations in the country and specifically cited transferring money from the transportation fund to fund ongoing

operations as an example of one of the practices that has put Wisconsin in such an untenable position; and

- WHEREAS, the debt service for these bonds will have to be paid for out of the state's general fund which hinders its ability to fund other programs like Shared Revenue, Youth Aids, Community Aids and courts in the future; and
- **WHEREAS**, using the state's general obligation (GO) bonds in this way has hurt the state's bonding rating. A report issued by CNN in 12009 listed Wisconsin as having the second worst GO bond rating in the country; and
- **WHEREAS**, gas tax and vehicle registration fees comprising over 90% of the state's segregated transportation account. Revenues from these two sources have been declining and are inadequate to meet the existing transportation needs in this state; and
- **WHEREAS**, Wisconsin's transportation infrastructure is a fundamental component in its ability to attract and retain business and produce jobs; and
- **WHEREAS**, the citizens of Waupaca County deserve the right to have their voices heard on this important issue; and
- **WHEREAS,** providing constitutional protection much like our neighbors in Minnesota, Iowa, Michigan, and Ohio have already have is the only way to ensure that this practice will not continue.
- **NOW, THEREFORE, BE IT RESOLVED** by the Waupaca County Board of Supervisors that the following question be put to the voters of Waupaca County in an advisory referendum during the November, 2010 election:

Should the Wisconsin Constitution be amended to prohibit any further transfers or lapses from the segregated transportation fund?; and

BE IT FURTHER RESOLVED that the County Clerk is directed to cause a copy of the Notice of Referendum to be published in the county's official newspaper as required by law; and

BE IT FURTHER RESOLVED that the County Clerk is directed to provide a copy of this resolution and a copy of the results of the advisory referendum to the Wisconsin Counties Association.

RESOLUTION NO. 19 (2010-2011)

Subject: Non-Represented Employees and Elected Officials Salary Adjustment

WHEREAS, the Waupaca County Finance and Personnel Committee considered wage/salary adjustments for non-represented county employees and;

WHEREAS, the Finance and Personnel Committee has concluded that non-represented employees and County Elected Officials (Sheriff, County Clerk, Treasurer, Register of Deeds, Clerk of Circuit Court and Coroner) annual rate of pay should be increased by 1% effective 1/1/2011 and 2% effective March 2011 and;

WHEREAS, the Finance and Personnel Committee also reviewed benefit adjustments for union and non-represented employees and determined the following benefit adjustments be applied to non-represented employees:

Employees completing an annual Health Risk Assessment offered by the County receive an annual payment of \$100; the non-represented group term life insurance policy be increased to \$15,000; during the annual enrollment period a contribution of \$75 will be made to each employee's Health Care Flexible Spending Account; the holiday schedule will be increased by ½ day for Christmas Eve and New Year's Eve; Highway non-represented employees will receive a \$20 increase in the annual safety shoe allowance; the Lakeview Manor non-represented employees working a .9 or greater full-time equivalent will receive an annual \$120 uniform allowance and part-time employees working a .5 to .9 full-time equivalent will receive an annual \$85 uniform allowance; and hourly non-represented employees working a 24/7 schedule in the Sheriff's Department and Lakeview Manor will be eligible to receive a wellness day if they do not use an unscheduled sick day for 6 consecutive months. Only one wellness day may be earned per year and must be used within 3 months and shall not be used for call in purposes.

NOW, THEREFORE, BE IT RESOLVED that the Waupaca County Board of Supervisors does hereby authorize the non-represented and elected officials wage/salaries be increased by 1% effective 1/1/2011 and 2% effective March 2011. The non-represented and elected officials benefits be adjusted upon passage of this resolution as outlined above.
