### WAUPACA COUNTY BOARD OF SUPERVISORS ADJOURNED ANNUAL SESSION December 21, 2010

Chair Koeppen called the meeting to order at 9:00 a.m. with 25 members present.

Supr. Allen was absent and Supr. Flink arrived at 9:10 a.m.

Chair Koeppen made the open meeting statement that this meeting and all other meetings of this board are open to the public. Proper notice has been posted and given to the press, in accordance with Wisconsin Statutes so the citizenry may be aware of the time, place and agenda of this meeting.

A moment of silent meditation was observed followed by the Pledge of Allegiance.

Supr. Hagen moved and Supr. G. Murphy seconded the motion to approve the minutes of the November 9, 2010 meeting. Motion carried 25-0. Passed the 21<sup>st</sup> day of December, 2010.

### REPORT NO. 10 (2010-2011) Waupaca County Economic Development Corp. Revolving Loan Fund - Deluxe Plastics, Inc.

Dave Thiel has received a request for a revolving loan fund for \$100,000 from Deluxe Plastics of Clintonville. Siggi Writt of Deluxe Plastics gave a short overview of the company. Supr. Craig moved and Supr. Kussmann seconded the motion to approve the revolving loan fund to Deluxe Plastics., Inc. Motion carried 26-0. Passed the 21<sup>st</sup> day of December, 2010.

Dave Thiel also reported that Uptown Pizza has closed and sold the building and equipment to the bank. WCEDC has been in negotiations with the bank to settle for half of what is owed and will then assign that debt back to the bank and write off the other half, approximately \$3,200. Supr. ## RESOLUTION NO. 29 (2010-2011) TO AMEND WAUPACA COUNTY ORDINANCE NO. 45 OF THE GENERAL CODE OF ORDINANCE COMPREHENSIVE PLAN MAP

**WHEREAS**, Wisconsin Statutes 66.1001 authorize the Waupaca County to adopt and amend a comprehensive plan map; and

**WHEREAS**, the Town Board adopted a comprehensive plan on March 13, 2007; and amended on October 12, 2010; and

**WHEREAS**, the current preferred land use classification for the roughly northern 20.06 acres of the roughly 25.0 acre property described as "All that part of the SW ¼ of the NE ¼ lying West of Hobson Road (Tax parcel 12 31 13 1), all lying and being in Section 31, Township 21 North, Range 13 East, Town of Lind, Waupaca County, Wisconsin" is Agriculture and Woodland Transition and is consistent with the agriculture preservation, economic development, and various other goals and objectives of the comprehensive plan; and,

WHEREAS, the current preferred land use classifications for the roughly western 18.20 acres of the 41.13 acre property described as "the SE ¼ of the NW ¼ excepting the South 200 feet of the West 218 feet (Tax parcel 12 31 24 1) all lying and being in Section 31, Township 21 North, Range 13 East, Town of Lind, Waupaca County, Wisconsin"; is Rural Residential and is consistent with the agriculture preservation, economic development, and various other goals and objectives of the comprehensive plan; and,

WHEREAS, the current preferred land use classifications for the roughly eastern 22.67 acres of the 41.13 acre property described as "the SE ¼ of the NW ¼ excepting the South 200 feet of the West 218 feet (Tax parcel 12 31 24 1) all lying and being in Section 31, Township 21 North, Range 13 East, Town of Lind, Waupaca County, Wisconsin"; are Agriculture and Woodland Transition and is consistent with the agriculture preservation, economic development, and various other goals and objectives of the comprehensive plan; and,

**WHEREAS**, changing the preferred land use classifications as noted complements nearby current and planned future land uses;

**NOW, THEREFORE, LET IT BE RESOLVED** that the County of Waupaca Planning & Zoning Committee does hereby recommend the Waupaca County Board of Supervisors adopt an Ordinance amending the Comprehensive Plan Map as originally adopted in Ordinance #45 as follows:

 The Ordinance shall amend the Preferred Land Use Map (Map 8-56) to reclassify the aforementioned properties' preferred land use classifications to Agriculture Retention and Private Recreation and Forestry as noted on map 8-56(b).

## **RESOLUTION NO. 35 (2010-2011)**

**WHEREAS**, Waupaca County is has one of the most diverse landscapes in Wisconsin which includes 45.2% of its land base in agriculture and 42% forested.

**WHEREAS**, combined agriculture and forestry has an impact of 548 million dollars annually and includes 15.5% of the county workforce.

**WHEREAS**, the Waupaca County-Year 2030 Comprehensive Plan establishes goals that include, maintaining the viability, operational efficiency and productivity of the agricultural and forest resources along with their economic, aesthetic, and environmental values.

**WHEREAS**, the Waupaca County Working Farm and Forest Lands Conservation Easement Program is the culmination of several historic and contemporary initiatives addressing local citizen concern for loss of farmland and fragmentation of forestland.

**WHEREAS**, the Waupaca County Working Farm and Forest Lands Conservation Easement Program empowers Waupaca County to accept voluntary conveyed conservation easements that protect viable farm and forest lands in perpetuity.

WHEREAS, John T. Gilligan/Janice L. Ereth is voluntarily offering 140.88 acres in the Township of Lind further described as being part of Certified Survey Map Number 5542 as recorded in Volume 18 page 358 of the Waupaca County Registry, part of the Northeast Quarter of the Northwest Quarter, part of the Southeast Quarter of the Northwest Quarter, part of the Northwest Quarter of the Northeast Quarter, part of the Southwest Quarter of the Northeast Quarter, and all of the West Half of the Southeast Quarter of Section 31, Town 21 North, Range 12 East, in the Township of Lind, Waupaca County, Wisconsin. More completely described in Easement document.

**WHEREAS**, the land area described above meets all provisions of the Waupaca County Code of Ordinances Chapter 47, Waupaca County Voluntary Conservation Easement Donation Ordinance adopted by the Waupaca County Board of Supervisors on May 19, 2009.

**NOW, THEREFORE, LET IT BE RESOLVED** that the Waupaca County Board of Supervisors accept the land base described above into the Waupaca County Voluntary Conservation Easement Donation Program.

**12.7** Leadership Waupaca County. Any sitting County Board Supervisor may apply to the County Board Chair for authorization to submit an application to Leadership Waupaca County. The County Board Chair may select two members per year to attend the Leadership Program and to authorize payment of the full fee for each of the supervisors selected. There will be no per diem or mileage payment for participation in this course.

## WAUPACA COUNTY CODE OF ORDINANCES Amend Chapter 9, to create S. 9.07 (a) Public Peace and Good Will

## 9.07(a) SYNTHETIC CANNABINOID PROHIBITED

- (1) Possession, use and sale are illegal. It shall be illegal for any person to use, possess, purchase, attempt to purchase, sell, publically display for sale or attempt to sell, give, or barter any one or more of the following chemicals whether under the common street or trade names of "Spice", "K2", "Genie", "Yucatan Fire", "fake" or "new" marijuana, or by any other name, label, or description:
  - (a) Salviadivinorum or salvinorum A; all parts of the plant presently classified botanically as salvia divinorum, whether growing or not, the seeds thereof; any extract from any part of such plant, and every compound, manufacture, salts derivative, mixture or preparation of such plant, its seeds or extracts;
  - (b) (6aR, 10aR)-9-(hydroxymethyl)-6, 6dimethyl-3 (2methyloctan-2-yl)-6a, 7, 10, 10a-tetrahydrobenzo[c]chromen-l-ol some trade or other names; HU-210;

- (c) 1-Pentyl-3-(1-naphthoyl) indole-some trade or other names; JWH-018/spice;
- (d) 1-Butyl-3-(Inaphthoyl) indole-some trade or other names: JWH-073;
- (e) 1-(3{trifluoromethylphenyl}) piperazine-some trade or other names: TFMPP; or
- (f) Any similar structural analogs.
- (2) Medical or dental use allowed. Acts otherwise prohibited under section 7.01(C)(1) shall not be unlawful if done by or under the direction or prescription of a licensed physician, dentist, or other medical health professional authorized to direct or prescribe such acts, provided that such use is permitted under state and federal laws.

Approved by Waupaca County Law Enforcement Committee on November 10, 2010. This amendment shall be effective upon approval by the Waupaca County Board of Supervisors and publication of same.

NOW, THEREFORE, BE IT RESOLVED, that the Waupaca County Board of Supervisors affirms, by means of this Resolution, the designation of property described in the use agreement and application as a School/Community Forest.
