AMENDMENT TO CHAPTER NO. 34 Town of Royalton, AWT District to an RI-I District 2012-527, Z004-12

Parcel #16-09-22-3, Z-004-12, Scott & Sharon Spiegelberg in Sec. 9, Town of Royalton for a Zoning Map Amendment from an AWT (Agriculture and Woodland Transition) District to an RI-I (Rural Industrial - Intensive) District with a Conditional Use Permit application for heavy industrial to allow for metal fabrication of farm related equipment.

An amendment to amend the Waupaca County Zoning Ordinance by changing the zoning classification of certain specified lands located in part of the NW ¼ of the

NW ¼ of Sec. 9, Town of Royalton, Fire Number E5750, lying along Highway 54, Waupaca County, Wisconsin, on approximately 17.31 acres.

Subject matter of this ordinance having been duly referred to and considered by the Waupaca County Planning and Zoning Committee and public hearing having been held after the giving of requisite notice of said hearing and a recommendation thereon reported to the Board of Supervisors, Waupaca County, Wisconsin as required by Section 59.97 of the Wisconsin Statutes, said Board does ordain as follows:

- Section 1. The Zoning Map entitled Royalton Township, Waupaca County is hereby amended by changing the zoning classification of the area shown on the attached map, which is made a part of the ordinance from an AWT (Agriculture and Woodland Transition) District to an RI-I (Rural Industrial - Intensive) District.
- Section 2. This ordinance shall be in full force and effect in the Town of Royalton upon filing with the County Clerk of Waupaca County a certified copy of a resolution of the Town Board of Supervisors of said town approving said ordinance or 40 days after the adoption of the ordinance by County Board, unless a certified copy of a resolution disapproving the amendment is filed within ten (10) days with the County Clerk within that time.
- Section 3. All ordinances or parts of ordinances inconsistent with or in contravention of provisions of this ordinance are hereby repealed.

WHEREAS, **Waupaca County** and the Central Wisconsin Housing Consortium desire to and are required to, enter into a written cooperative agreement with each other to participate in such CDBG program, and

WHEREAS, **Waupaca County** and the Central Wisconsin Housing Consortium understand that Waupaca County will act as the applicant and will have the ultimate responsibility to assume all obligations under the terms of the grant including assuring compliance with all applicable laws and program regulations and performance of all work in accordance with the grant contract.

WHEREAS, it is understood that the Department of Housing and Urban Development and DOH have access to all participants' grant records and authority to monitor all activities,

NOW, THEREFORE, pursuant to Wisconsin Statutes 66.0301, **Waupaca County** and the Central Wisconsin Housing Consortium agree to cooperate in the submission of an application for such funds, and agree to cooperate in the implementation of the submitted CDBG program, as approved by the Department of Administration.

Nothing contained in this agreement shall deprive any municipality of any power or zoning, development control or other lawful authority which it presently possesses.
