**5.1** All resolutions of legislative, safety or security intent shall be presented to the Legislative, Judicial, Ethics, Safety & Security Committee for review with the exception of salary/compensation and any new positions unless directly related to this committee.

#### RULE NO. 13 – COMMITTEES OR BOARDS shall be amended to read:

# **13.3** Scheduling, Notices and Conduct of Meetings.

5. For all Standing Committees: A copy of the agenda, including the time and place of the meeting and of the matters to be discussed, with a time for public input/public comment, for items on the agenda or for placing an item on a future agenda, time limit set by Chair if necessary, shall be given to the County Clerk for posting on the public bulletin board and such other place(s) in the Courthouse which provide prompt and sufficient notice to the public as soon as possible after scheduling but not less than five (5) days prior to the meeting. County Board agendas are exempt from the Public Comment section of the agenda. Supr. Federwitz moved and Supr. Handrich seconded the motion to adopt the amendment to Chapter 2, Rule 13.3 of the Waupaca County Code of Ordinances. Motion carried 21-5 with Suprs.
