# AMENDMENT TO THE WAUPACA COUNTY CODE OF ORDINANCES Chapter 32 -- Waupaca County Shoreland Zoning Ordinance

The Waupaca County Board of Supervisors does hereby ordain and enact the following amendments to the Waupaca County Shoreland Zoning Ordinance, Chapter 32:

Selected revisions to the Waupaca County Shoreland Zoning Ordinance are necessary to ensure that the Ordinance will remain in compliance with state requirements and be consistent with the 2011 Wisconsin Act 170 and the Administrative Code NR 115.

#### **EFFECTIVE DATE**

Approval of the Planning & Zoning Committee and Upon enactment of the County Board of Supervisors, the amendment will be in full force and effect within Waupaca County and each Town as provided in Section 59.69(5)e, Wis. Stats.

Supr. Ellis moved and Supr. Kussmann seconded the motion to adopt the revisions to Chapter 32 of the Waupaca County Code of Ordinances. Supr. Flease moved and Supr. Penney seconded the motion to amend Section 5.58 as follows:

#### 5.58 **View Corridor**

1) Establishment of view and access corridor(s) on each lot containing a principal structure may be created by the removal of trees and shrubs and selective pruning in the vegetation protection area to create viewing and access corridors,

provided that the combined width of the viewing and access corridor(s) on a riparian lot or parcel may not exceed the lesser of thirty (30) percent of the shoreline frontage or one hundred (100) feet. Sufficient trees and shrubbery shall be retained to screen development from view from the water.

2) Clear cutting, filling, grading, and other land disturbing activities are not permitted on trout streams listed in the most current Wisconsin Department of Natural Resources Publication "Wisconsin Trout Streams".

Motion on the amendment carried 18-5 with Suprs. Kussmann, Handrich, G. Murphy, Ellis, and Craig voting no. Passed the 18<sup>th</sup> day of February, 2014. Motion on the main motion as amended carried 17-6 with Suprs. Kussmann, Handrich, Much, Mares, G. Murphy, Ellis voting no. Passed the 18<sup>th</sup> day of February, 2014.

### **RESOLUTION NO. 38 (2013-2014)**

**SUBJECT:** The Health and Human Services Board recommends the Department submit application for a Coordinated Services Team (CST) Initiative Statewide Expansion Funding issued by the State of Wisconsin under the Department of Health Services.

**WHEREAS,** Waupaca County was awarded an initial five year Systems Change Grant by the State in 1995; and,

**WHEREAS**, this grant provided the base for our department to start a new way of doing business with our children and families and with our community partners; and,

**WHEREAS**, our Coordinated Services Team (aka Integrated Services Program) Core Values, such as family centered, consumer involvement, strength based, unconditional care, collaboration across systems, etc., were created by the Systems Change Grant, and continue to be the systems approach supported by the State for assisting children and families; and,

**WHEREAS,** these new grant funds will assist our CST/ISP Committee and Prevention Policy Board to expand these core values, provide direct support for children and families, and train our staff and community partners; and,

**WHEREAS,** this CST Program expansion funding request may be awarded for up to three years with a \$63,123 maximum award. This funding expansion request will require a 20% match from the Department of Health and Human Services of approximately \$12,500; and,

**WHEREAS**, it is projected that this additional funding would support an additional full-time FTE for the current CST program. It is projected that this addition to the intensive case management program should provide a reduction to the out of home care budget for children; and,

**WHEREAS,** there is currently a waitlist for CST services, it is projected that throughout a year, this expansion would allow 18 additional families to be served through this voluntary, strength-based program.

**NOW, THEREFORE, LET IT BE RESOLVED** that the Waupaca County Board of Supervisors authorizes the Health and Human Services Department to submit an application for a Coordinated Services Team Initiative Statewide Expansion Funding.
