WHEREAS, Waupaca County Highway Special Building Committee, after review of all written responsive proposals and after hearing presentations by five architectural and engineering firms, selected Bray Associates-Architects as its top candidate for this project; and

WHEREAS, the successful completion of Phase 1 Pre-Design services will include the following: A preliminary space needs analysis for the Highway Department Facility; development of a master plan for the entire site in five, ten and twenty-year timeframes based on the needs assessment, including future needs of the Highway

Department including site development and/or expansion alternatives; and a report on sustainable/green alternatives and any available funding sources.

WHEREAS, upon the completion of Phase 1, construction cost estimates for site development, building costs for garage/shop and administrative areas, parking areas, outside storage, and furnishing using current industry guidelines and space standards for each function will be provided to the Highway Special Building Committee for review and recommendation to the Waupaca County Board of Supervisors.

WHEREAS, Waupaca County Highway Committee budgeted funds up to \$7,500 for Phase 1 in its Highway Enterprise Fund.

NOW THEREFORE BE IT RESOLVED, upon the recommendation of Waupaca County Highway Special Building Committee, Waupaca County Board of Supervisors authorizes the hiring of Bray Associates-Architects, Inc. to complete Phase 1 of the Architectural & Engineering Services for Waupaca County Highway Department Facility.

WHEREAS, deposits in banks, savings and loan associations, and credit unions which are state and federally chartered, the State of Wisconsin Local Government Pool, the WISC Fund, the purchase of bonds or securities issued, qualify for the public deposit of County Funds not immediately needed under authority granted by Section 59.62 and Section 66.0603, Wisconsin Statutes; and

WHEREAS, PMA Securities and Associated Trust Company have been designated as Waupaca County Investment Advisors; and

NOW, THEREFORE, LET IT BE RESOLVED that the Waupaca County Board of Supervisors hereby designates all those banks, savings banks and credit unions chartered under State and Federal Law, State of Wisconsin's Local Government Pooled Investment Fund, the WISC Fund, Associated Trust Company, First National Bank, Fox Valley, ICS Service as County depositories; and

BE IT FURTHER RESOLVED that the Waupaca County Treasurer secures investments in excess of the amount covered by the appropriate Federal Insurance and the State of Wisconsin, per 1985 Wisconsin Act 25, with securities of the U.S. Treasury, Agencies, Certificates of Deposit drawn on a Federal Home Loan Bank or a Bank Deposit Guarantee Bond, and that pledged securities or deposit insurance have a cumulative face value totaling minimum of 110% of the invested amounts over those secured by the appropriate Federal Insurance and 1985 Wisconsin Act 25; and

BE IT FURTHER RESOLVED that effective January 1, 2017 the County Clerk and County Treasurer be authorized to sign all documents and legal county papers and sign all checks, signatures shown below:
