## WAUPACA COUNTY BOARD OF SUPERVISORS SPECIAL COUNTY BOARD SESSION JANUARY 9, 2017

Chair Koeppen called the meeting to order at 10:00 a.m. with 24 members present.

Chair Koeppen made the open meeting statement that this meeting and all other meetings of this board are open to the public. Proper notice has been posted and given to the press, in accordance with Wisconsin Statutes so the citizenry may be aware of the time, place and agenda of this meeting.

Supr. G. Murphy moved and Supr. Whitman seconded the motion approving the agenda. Motion carried 24-0. Passed the 9<sup>th</sup> day of January, 2017.

A moment of silent meditation was observed followed by the Pledge of Allegiance.

Waupaca County Corporation Counsel Diane Meulemans acted as spokesperson for the Lakeview Manor Committee and presented Resolution No. 28 (2016-2017).

## RESOLUTION NO. 28 (2016-2017) APPROVING THE CLOSURE OF LAKEVIEW MANOR

**Subject: Termination of Operations at Lakeview Manor** 

**WHEREAS**, Lakeview Manor has been a publicly operated health care facility for over one-hundred (100) years; and

WHEREAS, Lakeview Manor has a distinguished history of providing quality long-term and recuperative health care services to the citizens of Waupaca County; and

**WHEREAS**, over the past years, the costs of operating Lakeview Manor have exceeded, and continue to exceed, the revenues generated by the facility, placing a financial burden on the taxpayers of Waupaca County with a levy impact in recent years approaching one million dollars per year; and

**WHEREAS,** Waupaca County has faced repeated staffing shortages at the facility, including in the critical positions of Nursing Home Administrator, Director of Nursing and Registered Nurses; and

**WHEREAS,** in 2016, Waupaca County Board, at the recommendation of the Human Resources Committee, approved an incentive package for employees at

Lakeview Manor for a six-month period with the goal of increasing current employee stability and in attracting new, qualified employees; the total cost of incentives was \$250,000 with limited success; and

**WHEREAS,** Lakeview Manor risks citations from the State of Wisconsin Department of Health Services for insufficient staffing which may include monetary penalties; and

WHEREAS, Waupaca County is competing for private pay and Medicare residents with other facilities, and the State of Wisconsin reimbursement for Medicaid residents does not cover the cost of providing care; and

**WHEREAS**, there are an adequate number of nursing home beds available in Waupaca County to provide care for the residents of Lakeview Manor and their families.

NOW, THEREFORE, BE IT RESOLVED BY THE WAUPACA COUNTY BOARD OF SUPERVISORS that the Notice of Intent to Relocate residents be filed with the State of Wisconsin Department of Health Services and the nursing home close within the statutory time frames.

**BE IT FURTHER RESOLVED**, Lakeview Manor Committee continue negotiations for the best use of the buildings and land immediately surrounding Lakeview Manor, including sale or lease of the property with final sale approved upon passage of the Waupaca County Board of Supervisors.
