Chair Koeppen called the meeting to order at 9:00 a.m. with 22 members present.

AMEND CHAPTER 7.04 OF THE WAUPACA COUNTY CODE OF ORDINANCES

SUBJECT: SPEED RESTRICTION – County Trunk Highway "G," "E," and "C"

The Waupaca County Board of Supervisors does hereby ordain as follows:

On County Trunk Highway C the speed limit shall change as follows:

to 25 miles per hour from Intersection of County Road C, E and G to the west 0.034 miles on the north side of County Road C;

to 35 miles per hour from Intersection of County Road C, E and G to the west 0.255 miles on the north side of County Road C;

to 55 miles per hour from Intersection of County Road C, E and G to the west 0.526 miles on the north side of County Road C;

to 25 miles per hour from Intersection of County Road C, E and G to the west 0.255 miles on the south side of County Road C;

to 35 miles per hour from Intersection of County Road C, E and G to the west 0.526 miles on the south side of County Road C; and

shall reduce from 55 miles per hour to 35 miles per hour from Intersection of County Road C, E and G to the west 0.728 miles on the south side of County Road C.

On County Truck Highway G the speed limit shall change as follows:

to 25 miles per hour from Intersection of County Road C, E and G to the east 0.024 miles on the south side of County Road G;

to 35 miles per hour from Intersection of County Road C, E and G to the east 0.287 miles on the south side of County Road G;

to 55 miles per hour from Intersection of County Road C, E and G to the east 0.471 miles on the south side of County Road G;

to 25 miles per hour from Intersection of County Road C, E and G to the east 0.283 miles on the north side of County Road G;

to 35 miles per hour from Intersection of County Road C, E and G to the east 0.471 miles on the north side of County Road G; and

reduce from 55 to 35 miles per hour from Intersection of County Road C, E and G to the east 0.664 miles on the north side of County Road G.

On County Trunk Highway E the speed limit shall change to 55 miles per hour from Intersection of County Road E and G on the east side of County Road E

On County Trunk Highways C, E and G the speed limit shall change as follows:

to 25 miles per hour from Intersection of County Road C, E and G and Oak Street 0.178 miles on the east side of County Road C, E, G; and

to 35 miles per hour from Intersection of County Road C, E and G and Oak Street 0.178 miles on the west side of County Road C, E, G.

On County Trunk Highways E and C the speed limit shall change as follows:

to 55 miles per hour from Intersection of County Road C, E and G and Oak Street 0.554 miles on the south side of County Road E & C;

to 35 miles per hour from Intersection of County Road C, E and G and Oak Street 0.554 miles on the north side of County Road E & C; and

reduce from 55 to 35 miles per hour from Intersection of County Road C, E and G and Oak Street 0.674 miles on the north side of County Road E & C.

This ordinance shall be effective upon installation of standards signs giving notice thereof.

REVOLVING LOAN FUND APPLICATION Fischer Services & Sales, LLC Dave Thiel, WCEDC Executive Director

Dave Thiel introduced Jeff Fischer who has applied for a Waupaca County Revolving Loan to start Fischer Service & Sales LLC which would be located on Hwy 22 in Waupaca. Dave noted that the Revolving Loan Fund Committee has approved the application, and that CAP Services is in the process of approving their own loan for the project, once all requirements have been met. The loan is for \$105,000 with 4% interest with a 7-year lock and a 20-year amortization. Dave also noted that Mr. Fischer would also be required to create 3 jobs within the next three years. The committee asked questions related to the business plan and life insurance requirements. Lisa Rader from CAP Service noted that they will be working with Mr. Fischer through the life of the loan and that CAP Services would discuss approval of their loan for him at their January 31 meeting.

MOTION: Supr. Spierings moved and Supr. T. Murphy seconded the motion to approve the Waupaca County Revolving Loan \$105,000 with 4% interest with a 7-year lock and a 20-year amortization contingent on CAP Services approving their loan and that Mr. Fisher have at least a \$250,000 life insurance policy. Motion carried 22-0. Passed the 16th day of January, 2018.
