CURRENT ENROLLMENT: Jan reported she is facilitating CCS cases for nine actively enrolled consumers. Jan is providing psychotherapy services for two mental health clients in the behavioral health program.

CST CASE MANAGERS CERTIFIED FOR CCS FACILITATION: There are five CST case managers completing training for CCS facilitation. There are five open clients through them. Two new clients are moving here from Shawano County. Two consumers started in mental health. There are 5 new referrals. Ted will start July 5 as a CCS Facilitator. We have a total of 23 CCS clients.

PROVIDER ORIENTATION AND TRAINING: Jan and Lori Martin along with a consumer held a training on June 8.

Waushara County held a training on TARP notes. Joanne Stevens, a consumer, spoke on TIC and recovery principles. 26 people attended.

Rawhide and Catalpa are two new providers that will be opening offices in Waupaca County to provide outpatient therapy.

PEER SPECIALIST TRAINING UPDATE: The State is in the process of hiring a peer specialist for each region. Sherrie reported we are looking at hiring an internal peer support specialist for Waupaca County in the next year.

CONSUMER COMMITTEE: Jan and Jill attended a Regional CCS Coordinating Committee meeting. Jill is now our official member for the Regional CCS Coordinating Committee. Jill spoke about the region forming a Consumer Committee. The Consumer Committee meets for an hour prior to the Regional CCS Coordinating Committee.

STATEWIDE PAPERWORK TOOLKIT: The State held a workshop on paperwork for CCS for our six county consortium. A State-wide format is offered. We as a region have been reviewing this with Lori Martin.

NEXT MEETING DATE: Friday, August 25 and Friday, October 27. The meeting scheduled for December 22 has been changed to Tuesday, December 19.
