## **OPEN SESSION**

**AGENDA MOTION:** Supr. Craig moved and Supr. G. Murphy seconded the motion to approve the agenda. The motion carried without a negative vote.

**2017 Budgets – Finance Director Heidi Dombrowski.** Heidi reviewed the proposed General Fund. Operating Levy remaining is \$180,356 applying some fund balance. Department Head recommendations presented to the committee totaling \$251,549.00. Reviewed summary of Waupaca County Year 2017 and Proposed Operating Special Purposes and Debt Service Budgets. Capital Outlay was discussed and Heidi distributed a sheet of capital items. Public Property committee would like to have a facility study done for the courthouse before we make too many changes to alter the building for security. We are currently 10% over our Policy.

**Motion:** Supr. Barrington moved and Supr. Flease seconded the motion to put in the budget \$33,500 specifically to be used for Drug/Treatment Court funds beginning September 1, 2017. The motion carried without a negative vote.

**Motion:** Supr. Flease move and Supr. Penney seconded the motion to remove courthouse security for 2017 from the budget. The motion carried without a negative vote.

**Motion:** Supr. Craig moved and Supr. Penney seconded the motion to increase salaries to 1% for 2017.

**Memo of Understanding.** Waupaca County waiver of delinquent taxes with agreement from the City of Clintonville. **Motion:** Supr. Barrington moved and Supr. Flease seconded the motion to approve writing off previous taxes and City of Clintonville will pay back \$5,316.94 2016 taxes and secure a quit claim deed for ownership. The motion carried without a negative vote.
