REVIEW AND APPROVE AGENDA. - MOTION: Supr. Penney moved and Supr. Craig seconded the motion to approve agenda. The motion carried without a negative vote.

MINUTES OF PREVIOUS MEETINGS – MOTION: Co. Bd. Chr. Koeppen moved and Supr. G. Murphy seconded the motion to approve the minutes of the October 25, 2017 meeting. The motion carried without a negative vote.

- 1. Res. No. 27 (2017-18) Budget Amendment Sheriff Department
 - a. Sheriff Hardel gave an overview regarding the need to amend the 2017 budget by \$200,000 to provide upgrades to the E911 Dispatch System **Motion:** Supr. Craig moved and Co. Bd. Chr. Koeppen seconded the motion to approve Resolution No. 27 (2017-18) and forward to County Board. The motion carried without a negative vote.
- 2. Finance Director's Report Heidi Dombrowski
 - a. Heidi asked if there were any additional questions by the committee or brought to the committee regarding the 2018 Budget. None were noted.
 - b. Res. No. 28 (2017-18) Set 2018 Tax Levy Rate. **Motion:** Co. Bd. Chr. Koeppen moved and Supr. Neumann seconded the motion to approve Res. No. 28 (2017-18) and forward to County Board. The motion carried without a negative vote.
 - c. Heidi brought to the attention of the committee that due to Lakeview Manor Nursing Home being Vacant, coverage changes with our current plan. She noted a couple options for insuring with the lesser of the two plans having a building value of \$9,000,000. The committee asked her to look into coverage with a value of both 3 and 6 million and report to the committee next month.

 - e. Monthly Vouchers. **Motion:** Supr. Craig moved and Supr. G. Murphy seconded the motion to approve the monthly vouchers and Chr. Koeppen abstained from the vote. Motion carried.
