Corporation Counsel Meulemans gave an update to the committee on Thiel Pit. There has been no progress towards transfer of the reclamation permit to American Asphalt despite County efforts. There is a scheduling conference on March 17, 2017 for the Town of Little Wolf v. Waupaca County appeal of the Board of Adjustment decision on the Thiel Pit.

Mr. Beyersdorf updated the committee on the New Highway Facility. He stated he will be visiting Jefferson County Highway Department on Monday, March 13, 2017 for a space-needs study.

Mr. Beyersdorf gave an update to the committee on personnel. He stated applications for the Equipment Operator II position are done tomorrow, March 10, 2017. LTE's (Summer Help) and Highway Office Specialist are currently posted for applicants.

Mr. Beyersdorf reviewed the Commissioner's Report and gave the committee an update on Project Activities, financial reports, and important dates before the next committee meeting.
