WAUPACA COUNTY HIGHWAY COMMITTEE MINUTES – July 13, 2017

Chairman Flease called the meeting to order at 9:00 a.m. and gave the open meeting statement.

Roll Call: Chairman Flease, G., Supervisors Jonely, McClone, Much and Rohan.

Also present –Casey Beyersdorf, Highway Commissioner, Sue Popham, Highway Office Specialist and Gene Goode, Part-time Police Chief, Village of Fremont

Audience – Bobbi Marks, Village Trustee for Village of Fremont

Review and Approve Agenda. Motion: Supervisor McClone moved and Supervisor Much seconded the motion to approve the agenda. The motion carried without a negative vote.

Minutes of the previous meeting – June 29, 2017 regular meeting. Motion: Supervisor Jonely moved and Supervisor Rohan seconded the motion to approve the minutes of the previous meeting. Motion carried without a negative vote.

Public Comment – None

Review and Approve payment vouchers. Motion: Supervisor Jonely moved and Supervisor Much seconded the motion to approve the bill batch dated 6-29-17. Motion carried without a negative vote.

Review and discuss ATV/UTV Trails in Waupaca County – Gene Goode. Mr. Beyersdorf introduced Gene Goode who works at the Waupaca County Sheriff's Dept. and is also the part-time Chief of Police for the Village of Fremont. Mr. Goode is seeking approval from the Highway Committee to have the STH 110 bridge and CTH H used as an ATV/UTV trail connection route. Mr. Goode is also in the process of getting more counties involved in allowing ATV/UTV access to roadways to allow travel accessibility between towns. Mr. Beyersdorf will consult with Diane Meulemans, Corporation Counsel, and discuss looking at templates, possibly from other counties that have ATV/UTV policies in place, to come up with a policy for Waupaca County for using roads as connecting ATV/UTV routes.

Review/discuss 50/50 Local Bridge/Culvert petitions and accounts. Mr. Beyersdorf stated that municipalities participate in putting money towards this program and then they can petition to receive 50/50 assistance from the Highway Department for bridge work done in their township, city or village. We need to clean the books of projects from up to 17 years ago so that we can get a clear picture of the amount remaining in this program. Mr. Beyersdorf will review the process involved in the 50/50 petitions and see if we need to set deadlines and dollar amounts. This information will be brought to the Highway Committee at the next meeting for further review.

Review and Approve Capital Purchase Requests. Mr. Beyersdorf went over the capital purchase requests that were reviewed last meeting. The budget amount was changed from \$1.4 million to \$1.2 million to budget for new capital highway equipment in 2018.
