Terry Murphy called the meeting to order at 11:30 AM and read the open meetings statement.

**Review and Accept Agenda**

**Off-site Cloud Backup Solution**

Ian Grasshoff stated that he had selected Zetta, Inc. as a cloud backup solution provider. Ian G. explained that all GIS web servers and GIS databases are now backed up off-site using Zetta. Ian G. went on to explain the Zetta software stores 30 days of file system changes and 7 days worth of database transactions.

**GIS Web Viewer Upgrades**

Ian Grasshoff presented a brief overview of the current technology that is utilized to deliver GIS maps to citizens through a web browser. Ian G. told the council that previous technology did not support using maps on mobile devices. Ian explained that was the main reason for the GIS web viewer software upgrades.

**Project: Semi-Automated Water Feature Extraction from Aerial Imagery**

Ian Grasshoff gave a brief presentation outlining a GIS tool he developed to automatically map surface water features. Ian G. further explained that our 2015 aerial imagery contains a fourth band of sensor data, the near infrared portion of the electromagnetic spectrum. Ian explained that the fourth band could be used to distinguish surface water features from other land cover. Ian G. showed several examples of map results generated by the GIS tool he developed.

**Potential LiDAR Update in 2018**

Ian Grasshoff informed the council that the county's current LiDAR data was collected in 2005. Ian G. went on to explain that he was notified of a grant opportunity to fund up to 50% of a new LiDAR acquisition project. Ian G. explained that several counties in the Fox Valley region were also interested in acquiring new LiDAR in 2018. Ian G. further explained that grants are prioritized if they cover a large geographic region, so it makes sense to coordinate with neighboring counties. Lastly, Ian G. explained that in order to fund the project we might need to skip a GPS control project in 2018.
