## LAW ENFORCEMENT MEETING

The Waupaca County Law Enforcement Committee was called to order at 9:00 a.m. by Chairman Jonely. Members present: Supervisors Craig, Handrich, Johnson, and Wilfuer. Chairman Jonely gave the opening meeting statement that this meeting and all other meetings of this Committee are open to the public. Proper notice has been posted and given to the press in accordance with Wisconsin Statutes so that the citizenry may be aware of the time, place and agenda of this meeting.

Captain Wilz reported for the Communication Center that there have been recent issues with their recording system. A new system is been looked at with Eventide. Dispatch continues to have issues with the Citrix system; to the extent that Citrix was removed.

Captain Wogsland introduced new Corrections Officer Clint Schroeder, who started on 08/10/15. Background checks are being done on two individuals. A new head nurse started last week. The jail is looking at having a nurse on duty 24/7. Four new wheel chairs were purchased. A summary of the recent jail inspection was given.

Captain Conat reported on a strong-arm robbery recently in the Village of Scandinavia. The suspect was apprehended and the money recovered. A 16-year-old had recently been reported missing while fishing. He was found after walking in the wrong direction of his pick-up. There was a recent suicide in Symco. A new recording system is being looked at to place the system installed in 2006-2007.

Captain Rasmussen reported on Patrol division statistics. Supervisor Johnson moved, Supervisor Handrich second to approve the report. Motion carried without a negative vote. The patrol report was placed on file. Captain Rasmussen also reported on the State filing charges recently on two old fatalities in the county.

Sheriff's Office report was presented by Chief Deputy Kraeger. Motion to approve the report by Supervisor Handrich, second by Supervisor Wilfuer. Motion carried without a negative vote. The sheriff's report was placed on file.

Sheriff Hardel reported that Waupaca County will be hosting the Badger State Sheriff's Conference in Waupaca next week. The K-9 brat fry was successful, despite the rainy day. The drug officers continue to be very busy. The 2016 budget is being worked on.
