

## LAW ENFORCEMENT MEETING

8 December 2015

The Waupaca County Law Enforcement Committee was called to order at 9:05 a.m. by Vice Chairman Johnson. Members present: Supervisors Craig, Handrich, and Wilfuer. Others present: Sheriff Hardel, Chief Deputy Kraeger, Captain Conat, Captain Wilz, Captain Rasmussen, Captain Wogsland, Lt. Russell and County Board Chairman Dick Koeppen.

Vice Chairman Johnson gave the opening meeting statement that this meeting and all other meetings of this Committee are open to the public. Proper notice has been posted and given to the press in accordance with Wisconsin Statutes so that the citizenry may be aware of the time, place and agenda of this meeting.

Captain Wilz reported for the Communication Center that the last vacant dispatch position will be filled on January 4, 2016. Kim Allard has completed Phase 4 of her training and will be done with training by January 1, 2016. Captain Wilz told the committee that he will be retiring on July 1, 2016.

Captain Wogsland reported for the Jail that the shower project completion date will need to be extended due to illness. Clint Schroeder, Amelia Olsen and Ray Nendza have completed their training. There is currently one available position in the Jail.

Sheriff Hardel and Captain Conat reported for the Detective Division that they have been busy with the recent horse assault case as well as investigating a pick-up truck that was struck with a bullet while shining deer. Investigation continues into the theft of money from the Chain BP station.

Captain Rasmussen reported on Patrol Division statistics. Supervisor Handrich moved, Supervisor Wilfuer second to approve the report. Motion carried without a negative vote. The patrol report was placed on file.

Sheriff's Office report was presented by Chief Deputy Kraeger. Motion to approve the report by Supervisor Craig, second by Supervisor Wilfuer. Motion carried without a negative vote. The Sheriff's Office report was placed on file.

Sheriff Hardel reported on a recent truck vs. Amish buggy accident by Clintonville. Citizen Sarah Binder assisted at the scene to prevent possible injury to an infant that was pinned under the wheel of the overturned buggy. Dance hall permits for The Indian Crossing Casino, Cedar Springs Golf Course, Union Threshree, Inc. and Hucklberry Acres, Inc. were approved for 2016. Sheriff Hardel reported on the successful Shop-With-A-Cop on December 1. 39 children participated along with many volunteers.
