## LAW ENFORCEMENT MEETING <u>APPROVED</u> 11 OCTOBER 2016

Captain Wogsland reported for the Jail that there are four open corrections positions, with preliminary offers to two individuals. Fitting for the stab vests will be held shortly with 12-15 officers interested. The camera upgrade will begin in two weeks.

Captain Conat reported for the Detective Division that the newest detective, Tim Myers, is working out very well. Also, there is an inmate in Illinois that has DNA which matches one of our open cases.

Captain Rasmussen reported on the Patrol Division statistics. Supervisor Wilfuer moved, seconded by Supervisor Handrich to approve the report. Motion carried without a negative vote. The patrol report was placed on file.
